for terms expiring June 30, 2004:

Ann C. Kiley of Denver, Colorado, to serve as a Democrat, reappointed;

Kent C. Veio of Denver, Colorado, to serve as a Republican, appointed.

Education

After consideration on the merits, the committee recommends that **HB01-1035** be amended as follows and, as so amended be referred to the Committee of the Whole with favorable recommendation.

Amend reengrossed bill, page 2, line 2, strike "23-1-102 (4) and (5)," and substitute "23-1-102 (3) (a), (4), and (5),";

strike line 5 and substitute the following:

"terms of office. (3) (a) The commission shall consist of nine ELEVEN

members to be appointed by the governor with the consent of the senate. The members of the commission shall be selected on the basis of their knowledge of and interest in higher education and shall serve for four-year terms; except that, of the members first appointed to the commission, five members shall serve for terms of two years, and four members shall serve for terms of four years. No member of the commission may serve more than two consecutive full four-year terms.

(4) At the time of appointment, no member of the";

strike lines 6 through 12 and substitute the following:

"commission shall have been an officer, employee, or member of a governing board or an officer or employee of any state-supported institution of higher education in the state for a period of two years ONE YEAR prior to his appointment. During his OR HER term of office, no member of the commission shall be a member of the general assembly or an officer, employee, or member of a governing board or an officer or employee of a state-supported institution of higher education.";

line 13, strike "five" and substitute "five SIX";

line 18, strike "nine" and substitute "nine ELEVEN";

after line 22, insert the following:

"SECTION 2. 23-60-104 (2) (a) (I), Colorado Revised Statutes, is amended to read:

23-60-104. State board for community colleges and occupational education - student advisory council - state advisory council. (2) (a) (I) The board shall consist of eleven members, nine of whom shall be appointed by the governor with the consent of the senate. The board shall appoint a director of occupational education and a director of community and technical colleges with the qualifications and background specified by the board. Within thirty days of April 14, 1986, the governor shall appoint the initial members of the board. An initial appointee shall be authorized to act as a duly confirmed member of the board until such time as the senate has acted on such appointment. The governor may appoint, as a member of the board, any person who was a member of the board prior to its termination. No appointed member shall be an employee of any junior college, community or technical college, school district or agency receiving vocational funds allocated by the board, state or private institution of higher education, or state or private occupational school in the state. No appointed member shall be an elected or appointed statewide official of the state of Colorado or member of the governing board of any state-supported institution of higher education. The board shall at no time have more than five appointed members of any one political party. The board shall at all times have one member from each congressional district in the state. A vacancy on the board occurs whenever any member moves out of the congressional district from which he was appointed. A member who moves out of such congressional district shall promptly notify the governor of the date of such move, but such notice is not a condition precedent to the occurrence of the vacancy. The governor shall fill the vacancy as provided in paragraph (c) of this subsection (2). Members of the board shall be appointed so as to insure that all geographic areas of the state are represented. A state student advisory council of student members who are enrolled for a minimum of nine hours shall be elected, one each, from and by the student bodies of each of the campuses governed by the board.

by Senators Windels and Phillips; also Representative Alexander--The creation of a mechanism for authorizing grandparent visitation time with grandchildren in certain limited circumstance, and in connection therewith, authorizing grandparents to petition for grandchild visitation time when there is or had been a significant beneficial relationship for the child between the grandparent and the child and the party with legal custody of or decision-making responsibilities for the child has unreasonably denied the grandparent opportunity to visit the child and authorizing the court to grant grandchild visitation to grandparents who meet the standing requirements when there is a finding, by clear and convincing evidence, that the visitation is in the best interests of the child, that it is necessary to prevent harm or potential harm to the child, and that such visitation will not significantly interfere with the relationship between the child and the party with legal custody of or decision-making responsibilities for the child.
