That the House accede to the Senate amendments made to the bill, as said amendments appear in the rerevised bill, with the following changes:

**HB01-1155**

Amend rerevised bill, page 3, line 20, after "OFFENDER", insert "WHO IS REQUIRED TO REGISTER PURSUANT TO SUBSECTION (1) OR (3.5) OF THIS SECTION BECAUSE THE OFFENDER WAS", and after "ADULT", insert "AND";

line 23, strike "(V)," and substitute "(IV),".

Page 5, line 25, strike "(V)" and substitute "(IV)".

Page 10, line 5, strike " forty-four thousand nine hundred seventy-three" and substitute "one hundred thirty-eight thousand two hundred";

line 6, strike "(\$44,973) and 1.0 FTE," and substitute "(\$138,200) and 2.6 FTE,".
