person who he reasonably suspects is committing, has committed, or is about to commit a crime and may require him to give his name and address, identification if available, and an explanation of his actions. A PEACE OFFICER SHALL NOT REQUIRE ANY PERSON WHO IS STOPPED PURSUANT TO THIS SECTION TO PRODUCE OR DIVULGE SUCH PERSON'S SOCIAL SECURITY NUMBER. The stopping shall not constitute an arrest.

SECTION 10. 42-4-1707 (6), Colorado Revised Statutes, is amended to read:

42-4-1707. Summons and complaint or penalty assessment notice for misdemeanors, petty offenses, and misdemeanor traffic offenses - release - registration. (6) If the defendant is otherwise eligible to be issued a summons and complaint or a penalty assessment notice for a violation of this title punishable as a misdemeanor, petty offense, or misdemeanor traffic offense and if the defendant does not possess a valid Colorado driver's license, the defendant, in order to secure release, as provided in this section, must either consent to be taken by the officer to the nearest mailbox and to mail the amount of the penalty and surcharge thereon to the department or must execute a promise to appear in court on the penalty assessment notice or on the summons and complaint.
