After consideration on the merits, the Committee recommends the following:

HB01-1344 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, after line 27, insert the following:

2 "SECTION 2. Part 1 of article 1 of title 17, Colorado Revised
3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to
4 read:

5 **17-1-133. Appropriation to comply with section 2-2-703 - HB**
6 **01-1344.** (1) PURSUANT TO SECTION 2-2-703, C.R.S., THE FOLLOWING
7 STATUTORY APPROPRIATIONS, OR SO MUCH THEREOF AS MAY BE
8 NECESSARY, ARE MADE IN ORDER TO IMPLEMENT H.B. 01-1344, ENACTED
9 AT THE FIRST REGULAR SESSION OF THE SIXTY-THIRD GENERAL ASSEMBLY:

10 (a) FOR THE FISCAL YEAR BEGINNING JULY 1, 2001, IN ADDITION
11 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED FROM
12 THE CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302,
13 C.R.S., TO THE CORRECTIONS EXPANSION RESERVE FUND CREATED IN
14 SECTION 17-1-116, THE SUM OF SIXTY-NINE THOUSAND FOUR HUNDRED
15 SIXTY-SEVEN DOLLARS (\$69,467).

16 (b) FOR THE FISCAL YEAR BEGINNING JULY 1, 2002, IN ADDITION
17 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
18 DEPARTMENT OF CORRECTIONS, OUT OF ANY MONEYS IN THE GENERAL
19 FUND NOT OTHERWISE APPROPRIATED, THE SUM OF TWENTY-SIX THOUSAND

1 SIX HUNDRED EIGHTY-NINE DOLLARS (\$26,689).

2 (c) FOR THE FISCAL YEAR BEGINNING JULY 1, 2003, IN ADDITION
3 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
4 DEPARTMENT OF CORRECTIONS, OUT OF ANY MONEYS IN THE GENERAL
5 FUND NOT OTHERWISE APPROPRIATED, THE SUM OF TWENTY-SIX THOUSAND
6 SIX HUNDRED EIGHTY-NINE DOLLARS (\$26,689).

7 (d) FOR THE FISCAL YEAR BEGINNING JULY 1, 2004, IN ADDITION TO
8 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
9 DEPARTMENT OF CORRECTIONS, OUT OF ANY MONEYS IN THE GENERAL
10 FUND NOT OTHERWISE APPROPRIATED, THE SUM OF TWENTY-SIX
11 THOUSAND SIX HUNDRED EIGHTY-NINE DOLLARS (\$26,689).

12 (e) FOR THE FISCAL YEAR BEGINNING JULY 1, 2005, IN ADDITION TO
13 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
14 DEPARTMENT OF CORRECTIONS, OUT OF ANY MONEYS IN THE GENERAL
15 FUND NOT OTHERWISE APPROPRIATED, THE SUM OF TWENTY-SIX THOUSAND
16 SIX HUNDRED EIGHTY-NINE DOLLARS (\$26,689).

18 **SECTION 3.** 24-75-302 (2) (n), Colorado Revised Statutes, is
19 amended to read:

20 **24-75-302. Capital construction fund - capital assessment fees**
21 **- calculation.** (2) As of July 1, 1988, and July 1 of each year thereafter
22 through July 1, 2005, a sum as specified in this subsection (2) shall
23 accrue to the capital construction fund. The state treasurer and the
24 controller shall transfer such sum out of the general fund and into the
25 capital construction fund as moneys become available in the general fund
26 during the fiscal year beginning on said July 1. Transfers between funds
27 pursuant to this subsection (2) shall not be deemed to be appropriations
28 subject to the limitations of section 24-75-201.1. The amount which shall
29 accrue pursuant to this subsection (2) shall be as follows:

30 (n) On July 1, 2001, one hundred million dollars, plus one
31 hundred fifty-four thousand six hundred thirty-six dollars pursuant to
32 H.B. 97-1186; plus nine hundred five thousand seven hundred
33 twenty-three dollars pursuant to H.B. 97-1077, enacted at the first regular
34 session of the sixty-first general assembly; plus nine thousand eight
35 hundred ninety dollars pursuant to S.B. 98-021, enacted at the second
36 regular session of the sixty-first general assembly; plus three hundred
37 forty-nine thousand fifty-five dollars pursuant to H.B. 98-1160, enacted
38 at the second regular session of the sixty-first general assembly; plus

1 three hundred twenty-six thousand thirty-two dollars pursuant to H.B.
2 00-1107, enacted at the second regular session of the sixty-second general
3 assembly; plus ninety-seven thousand two hundred fifty-four dollars
4 pursuant to H.B. 00-1111, enacted at the second regular session of the
5 sixty-second general assembly; plus two hundred ninety-one thousand
6 seven hundred sixty-one dollars pursuant to H.B. 00-1158, enacted at the
7 second regular session of the sixty-second general assembly; plus one
8 million one hundred sixteen thousand nine hundred seventy-one dollars
9 pursuant to H.B. 00-1201, enacted at the second regular session of the
10 sixty-second general assembly; plus four hundred sixteen thousand eight
11 hundred two dollars pursuant to H.B. 00-1214, enacted at the second
12 regular session of the sixty-second general assembly; plus sixty-nine
13 thousand four hundred sixty-seven dollars pursuant to H.B. 00-1247,
14 enacted at the second regular session of the sixty-second general
15 assembly; PLUS SIXTY-NINE THOUSAND FOUR HUNDRED SIXTY-SEVEN
16 DOLLARS PURSUANT TO H.B. 01-1344, ENACTED AT THE FIRST REGULAR
17 SESSION OF THE SIXTY-THIRD GENERAL ASSEMBLY;"

18 Renumber succeeding sections accordingly.

19 Page 1, line 102, strike "**PROCEEDINGS.**" and substitute "**PROCEEDINGS,**
20 **AND MAKING AN APPROPRIATION THEREFOR.**".
