35 The following resolution was read by title and laid over one day under the

38 general assembly's constitutional role in determining
39 the congressional redistricting of Colorado.

40 WHEREAS, Federal law vests the states with original authority to
41 set the states' respective congressional district boundaries; and

42 WHEREAS, Colorado's constitution vests the General Assembly
43 with the sole and original authority to set Colorado's congressional
44 district boundaries; and

45 WHEREAS, Lawsuits have been filed in Colorado in both federal
46 and state district courts regarding the necessity to establish new
47 congressional district boundaries; and

48 WHEREAS, The United States supreme court has repeatedly ruled
49 that both state and federal courts should defer to legislative efforts to set
50 congressional district boundaries; and

1 WHEREAS, The first deadline for the next general election does
2 not occur until March 11, 2002; and

4 WHEREAS, The General Assembly will convene its next regular
5 session on January 9, 2002; now, therefore,

Be It Resolved by the House of Representatives of the Sixty-third General Assembly of the State of Colorado, the Senate concurring herein:

(1) That the General Assembly solemnly acknowledges its constitutional duty to establish new congressional district boundaries.
