Amend printed bill, page 2, line 12, after "DUTIES.", insert the following: "Per diem and other expenses paid under this section shall be FROM MONEYS APPROPRIATED FROM THE COLORADO WATER CONSERVATION BOARD CONSTRUCTION FUND. SECTION 2. Appropriation. In addition to any other appropriation, there is hereby appropriated, out of any moneys in the Colorado water conservation board construction fund created in section 37-60-121, Colorado Revised Statutes, not otherwise appropriated, to the department of natural resources, water conservation board, for operating expenses, for the fiscal year beginning July 1, 2002, the sum of ten thousand eight hundred dollars (\$10,800), or so much thereof as may be necessary, for the implementation of this act.". Renumber succeeding section accordingly. Page 1, line 102, strike "BOARD." and substitute "BOARD, AND MAKING AN APPROPRIATION IN CONNECTION THEREWITH.". Amend printed bill, page 7, after line 4, insert the following: "SECTION 3. Appropriation - adjustments to the 2002 long **bill.** (1) (a) In addition to any other appropriation, there is hereby

(1) (a) In addition to any other appropriation, there is hereby appropriated, out of moneys in the general fund not otherwise appropriated, to the department of public health and environment, division of health facilities, for the fiscal year beginning July 1, 2002, the sum of fifty-eight thousand five hundred fourteen dollars (\$58,514) and 1.1 FTE, or so much thereof as may be necessary, for the implementation of this act.

(b) In addition to any other appropriation, there is hereby appropriated, out of moneys in the general fund not otherwise appropriated, to the department of human services, office of adult and veterans services, aging services programs, for the fiscal year beginning July 1, 2002, the sum of one thousand eight hundred dollars (\$1,800), or so much thereof as may be necessary, for the implementation of this act.

(c) The general fund appropriation to the department of health care policy and financing, medical services premiums, is decreased by sixty thousand three hundred fourteen dollars (\$60,314). In addition, the department is not anticipated to receive sixty thousand three hundred fourteen dollars (\$60,314) federal funds. Although such funds are not appropriated, they are noted for the purpose of indicating the assumptions used relative to these funds.

(2) For the implementation of this act, appropriations made in the annual general appropriation act for the fiscal year beginning July 1, 2002, shall be adjusted as follows:

(a) The appropriation to the department of health care policy and financing, medical programs administration, for fiscal year beginning July 1, 2002, is decreased by two hundred five thousand nine hundred sixty-four dollars (\$205,964) and 1.0 FTE. Of said sum, eighty thousand six hundred five dollars (\$80,605) shall be from the general fund, and one hundred twenty-five thousand three hundred fifty-nine (\$125,359) shall be from federal funds. Although federal funds are not appropriated, they are noted for the purpose of indicating the assumptions used relative to these funds.

(b) The appropriation to the department of health care policy and financing, department of human services-medicaid funded programs, for fiscal year beginning July 1, 2002, is decreased by one hundred twenty-seven thousand nine hundred thirty dollars (\$127,930). Of said sum, sixty-three thousand nine hundred sixty-five dollars (\$63,965) shall be from the general fund and sixty-three thousand nine hundred sixty-five dollars (\$63,965) shall be from federal funds. Although federal funds are not appropriated, they are noted for the purpose of indicating the assumptions used relative to these funds.

(c) The appropriation to the department of public health and environment, division of health facilities, is decreased by eighty-nine thousand five hundred six dollars (\$89,506) cash funds exempt and 1.8 FTE.

(d) The appropriation to the department of human services, office of adult veterans services, aging services programs, is decreased by one hundred twenty-seven thousand nine hundred thirty dollars (\$127,930) cash funds exempt.

(e) The appropriation to the department of health care policy and financing, medical services premiums, is increased by one hundred forty-four thousand five hundred seventy dollars (\$144,570) out of moneys in the general fund. In addition, the general assembly anticipates that the department of health care policy and financing will receive the sum of one hundred forty-four thousand five hundred seventy dollars (\$144,570) in federal funds. Although such funds are not appropriated, they are noted for the purpose of indicating the assumptions used relative to these funds. ".

Page 1, line 103, strike "RESIDENTS." and substitute "RESIDENTS, AND MAKING AN APPROPRIATION IN CONNECTION THEREWITH.".

"SECTION 5. Appropriation. In addition to any other appropriation, there is hereby appropriated, out of any moneys in the division of insurance cash fund created in section 10-1-103, Colorado Revised Statutes, not otherwise appropriated, to the department of regulatory agencies, for the fiscal year beginning July 1, 2002, the sum

"SECTION 5. Appropriation. In addition to any other appropriation, there is hereby appropriated, out of any moneys in the general fund not otherwise appropriated, to the department of revenue, for the fiscal year beginning July 1, 2002, the sum of thirty-six thousand seventy-eight dollars (\$36,078), or so much thereof as may be necessary, for the implementation of this act.

SECTION 6. Effective Date. Sections 1, 2, 3, and 4 of this act shall take effect on July 1, 2002. Section 5 of this act shall take effect upon approval by voters, as part of the 2002 general election, of an increase in the sales tax levied by the regional transportation district pursuant to section 32-9-119.4, Colorado Revised Statutes.".

Appropriations After consideration on the merits, the committee recommends that **SB02-156** be amended as follows and, as so amended be referred to the Committee of the Whole with favorable recommendation.

Amend printed bill, strike everything below the enacting clause, and substitute the following:

"**SECTION 1.** The introductory portion to 37-92-102 (3), Colorado Revised Statutes, is amended to read:

37-92-102. Legislative declaration - basic tenets of Colorado water law. (3) Further recognizing the need to correlate the activities of mankind with some reasonable preservation of the natural environment, the Colorado water conservation board is hereby vested with the exclusive authority, on behalf of the people of the state of Colorado, to appropriate in a manner consistent with sections 5 and 6 of article XVI of the state constitution, such waters of natural streams and lakes as the board determines may be required for minimum stream flows or for natural surface water levels or volumes for natural lakes to preserve the natural environment to a reasonable degree. In the adjudication of water rights pursuant to this article and other applicable law, no other person or entity shall be granted a decree adjudicating a right to water or interests in water for instream flows in a stream channel between specific points, or for natural surface water levels or volumes for natural lakes, for any purpose whatsoever. The board also may acquire, by grant, purchase, DONATION, bequest, devise, lease, exchange, or other contractual agreement, from or with any person, including any governmental entity, such water, water rights, or interests in water IN SUCH AMOUNT as the board determines may be required IS APPROPRIATE for minimum stream flows or for natural surface water levels or volumes for natural lakes to preserve OR IMPROVE the natural environment to a reasonable degree. At the request of any person, including any governmental entity, the board

shall determine in a timely manner, not to exceed one hundred twenty days unless further time is granted by the requesting person or entity, what terms and conditions it will accept in a contract or agreement for the SUCH acquisition. by it from such person or governmental entity of water, water rights, or interests in water to be held by the board for minimum stream flows to preserve the natural environment to a reasonable degree. Any contract or agreement executed between the board and any person or governmental entity which THAT provides water, water rights, or interests in water to the board shall be enforceable by either party thereto as a water matter under this article, according to the terms of the contract or agreement. THE BOARD MAY NOT ACCEPT A DONATION OF WATER RIGHTS THAT EITHER WOULD REQUIRE THE REMOVAL OF EXISTING INFRASTRUCTURE WITHOUT APPROVAL OF THE CURRENT OWNER OF SUCH INFRASTRUCTURE OR THAT WERE ACQUIRED BY CONDEMNATION. THE BOARD MAY USE ANY FUNDS AVAILABLE TO IT, OTHER THAN THE CONSTRUCTION FUND CREATED IN SECTION 37-60-121, FOR ACQUISITION OF WATER RIGHTS AND THEIR CONVERSION TO INSTREAM FLOW RIGHTS. The board may initiate such applications as it determines are necessary or desirable for utilizing water, water rights, or interests in water appropriated, acquired, or held by the board, including applications for changes of water rights, exchanges, or augmentation plans. Prior to the initiation of any such appropriation or acquisition, the board shall request recommendations from the division of wildlife and the division of parks and outdoor recreation. The board also shall request recommendations from the United States Department of Agriculture and the United States Department of the Interior. Nothing in this article shall be construed as authorizing any state agency to acquire water by eminent domain or to deprive the people of the state of Colorado of the beneficial use of those waters available by law and interstate compact. Any appropriation made pursuant to this subsection (3) shall be subject to the following principles and limitations:

SECTION 2. Effective date. This act shall take effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly that is allowed for submitting a referendum petition pursuant to article V, section 1 (3) of the state constitution; except that, if a referendum petition is filed against this act or an item, section, or part of this act within such period, then the act, item, section, or part, if approved by the people, shall take effect on the date of the official declaration of the vote thereon by proclamation of the governor.".

MONEYS IN THE FUND MAY BE USED TO COVER ALL REASONABLE COSTS INCURRED IN ADMINISTERING THE MONEYS IN THE FUND.

(3) THE WATER QUALITY CONTROL COMMISSION AND THE COLORADO WATER CONSERVATION BOARD SHALL USE THE MONEYS TRANSFERRED PURSUANT TO SUBSECTION (2) OF THIS SECTION TO AWARD GRANTS, ON A COMPETITIVE BASIS AND IN A MANNER TO BE DETERMINED JOINTLY BY SUCH COMMISSION AND BOARD, TO ANY QUALIFIED RESIDENT OF COLORADO TO WORK TOWARD THE RESTORATION AND PROTECTION OF LAND AND NATURAL RESOURCES WITHIN WATERSHEDS IN COLORADO. QUALIFICATIONS FOR SUCH GRANTS SHALL BE DETERMINED JOINTLY BY THE COMMISSION AND THE BOARD IN COOPERATION WITH THE COLORADO WATERSHED ASSEMBLY.

(4) MONEYS GRANTED PURSUANT TO SUBSECTION (3) OF THIS SECTION SHALL NOT BE USED FOR LOBBYING OR FOR ANY OTHER POLITICAL PURPOSE, THE COSTS OF LITIGATION, OR TO REMOVE ANY DIVERSION OR IMPROVEMENT STRUCTURE.

SECTION 2. Appropriation. In addition to any other appropriation, there is hereby appropriated, out of any moneys in the Colorado watershed protection fund created in section 39-22-2303 (1), Colorado Revised Statutes, not otherwise appropriated, to the department of revenue, cash and document processing division, for data entry costs, for the fiscal year beginning July 1, 2002, the sum of eight hundred twelve dollars (\$812), or so much thereof as may be necessary, for the implemention of this act.".
