strike line 10 and substitute the following:

"shall deduct such amounts from the perpetual base";

line 12, after "Statutes,", insert "as directed by the commissioner of agriculture in accordance with section 39-29-109 (1) (g), Colorado Revised Statutes,";

line 19, strike "one";

line 20, strike "million dollars (\$1,000,000)" and substitute "the amounts transferred by the state treasurer in accordance with section 39-29-109 (1) (g), Colorado Revised Statutes,".

As amended, ordered engrossed and placed on the calendar for Third Reading and Final Passage.
