"SECTION 8. 5-3.5-101 (2), Colorado Revised Statutes, is amended to read:

5-3.5-101. Definitions. As used in this article, unless the context otherwise requires:

"Covered loan" means a consumer credit mortgage loan (2) transaction involving SECURED BY property located within this state that is considered a mortgage under section 152 of the federal "Home Ownership and Equity Protection Act of 1994", 15 U.S.C. sec. 1602 (aa), as amended, and regulations adopted pursuant thereto by the federal reserve board, including, without limitation, 12 CFR 226.32, as amended; except that if the total points and fees on a loan paid by the obligor at or before closing exceed six percent of the total loan amount, such loan shall be deemed to be a covered loan if the loan TRANSACTION otherwise meets the requirements of this subsection (2).

SECTION 9. 5-3.5-102 (1) (a), Colorado Revised Statutes, is amended to read:

5-3.5-102. Protection of obligors. (1) A covered loan is subject to the following limitations:

(a) **Limitation on balloon payment.** No covered loan may contain a provision for a scheduled payment that is more than twice as large as the average of earlier REGULARLY scheduled monthly payments, unless such balloon payment becomes due and payable not less than one hundred twenty months after the date of execution of the loan. This prohibition does not apply when the payment schedule is adjusted to account for the seasonal or irregular income of the obligor or if the purpose of the loan is a bridge loan connected with, or related to, the acquisition or construction of a dwelling intended to become the obligor's principal dwelling.

SECTION 10. 5-3.5-103 (1) (c), Colorado Revised Statutes, is amended to read:

5-3.5-103. Restricted acts and practices. (1) The following acts and practices are prohibited in the making of a covered loan:

(c) **Refinancing within a one-year period.** Within one year after having extended credit subject to 12 CFR 226.32 THIS ARTICLE 3.5, no lender shall refinance any COVERED loan subject to 12 CFR 226.32 to the same obligor into another COVERED loan subject to 12 CFR 226.32 unless the refinancing is in the obligor's interest. An assignee holding or servicing an extension of mortgage credit subject to $\frac{12 \text{ CFR } 226.32}{12 \text{ CFR } 226.32}$ THIS ARTICLE 3.5 shall not, for the remainder of the one-year period following the date of origination of the credit, refinance any COVERED loan subject to 12 CFR 226.32 to the same obligor into another COVERED loan subject to 12 CFR 226.32 unless the refinancing is in the obligor's interest. FIRST REPORT OF SECOND CONFERENCE COMMITTEE ON SB03-183

To the President of the Senate and the Speaker of the House of Representatives:

Your second conference committee appointed on SB03-183, concerning the modification of certain preschool through twelfth grade public education programs, and making appropriations in connection therewith, has met and reports that it has agreed upon the following:

1. That the Senate accede to the House amendments made to the bill, as the amendments appear in the rerevised bill, with the following changes:

Amend rerevised bill, page 10, strike line 22 and substitute the following:

"(II) A LIST OF ALL MONEYS EXPENDED, ENCUMBERED, OR OBLIGATED AS OF JANUARY 31, 2003,";

line 23, strike "OF THIS SUBSECTION (4.5)";

line 27, strike "EXPENDITURES" and substitute "EXPENDITURES, ENCUMBRANCES, OR OBLIGATIONS".

Page 11, strike lines 2 through 11 and substitute the following:

"(c) ONCE A CHARTER SCHOOL EXPENDS AMOUNTS THAT WERE ENCUMBERED OR OBLIGATED AS OF JANUARY 31, 2003, AS DESCRIBED IN SUBPARAGRAPH (II) OF PARAGRAPH (b) OF THIS SUBSECTION (4.5), THE";

line 14, strike "FROM THE";

strike lines 15 through 19;

after line 23, insert the following:

"(e) Of the amount of state education fund moneys appropriated for the 2002-03 budget year pursuant to paragraph (a) of this subsection (4.5), any amount not distributed pursuant to paragraph (b) of this subsection (4.5) shall remain in the state education fund.

SECTION 10. 22-54-104.1 (1), (4), and (5), Colorado Revised Statutes, are amended to read:

22-54-104.1. General fund appropriations requirements - maintenance of effort base - general fund appropriation for 2001-02 and 2002-03 fiscal years. (1) In accordance with section 17 (5) of article IX of the state constitution, for state fiscal years 2001-02 through 2010-11, the general assembly shall annually appropriate from the general fund for total program under the provisions of this article an amount equal to the maintenance of effort base plus an amount as determined annually by the general assembly that is equal to at least five percent of the maintenance of effort base, UNLESS COLORADO PERSONAL INCOME GROWS LESS THAN FOUR AND ONE-HALF PERCENT BETWEEN THE TWO CALENDAR YEARS PRECEDING THE STATE FISCAL YEAR IN WHICH AN APPROPRIATION IS MADE.

(4) (a) The general assembly hereby finds and declares that:

(1) The current economic slowdown being experienced in Colorado has significantly reduced the amount of revenues the general assembly has available to fund state services and programs during the 2001-02 state fiscal year and has caused the general assembly to modify its decisions regarding the objects and level of support for which state revenues are to be expended during said state fiscal year;

(II) As a result of this revenue shortfall, it is necessary to reduce the amount of general fund revenues appropriated for total program for the 2001-02 state fiscal year to the minimum amount necessary to comply with the maintenance of effort requirement set forth in subsection (1) of this section;

(III) It is financially prudent to make a one-time increase in the amount of general fund revenues appropriated for total program for the 2002-03 state fiscal year sufficient to offset any impact that the reduction in the amount of general fund revenues appropriated for total program for the 2001-02 state fiscal year might have on the long-term solvency of the state education fund; and

(IV) This one-time increase in the amount of general fund revenues appropriated for total program for the 2002-03 state fiscal year shall not be construed to bind any future general assembly to maintain the same or similar rate of increase in the amount of general fund revenues appropriated for total program in any future state fiscal year.

(b) For the 2002-03 state fiscal year, the general assembly shall appropriate from the general fund for total program pursuant to the provisions of this article an amount equal to the maintenance of effort base plus an amount equal to seven and thirty-nine one-hundredths percent of the maintenance of effort base.

(5) For the 2002-03 state fiscal year, the general assembly shall appropriate from the general fund for total program pursuant to the provisions of this article an amount equal to the maintenance of effort base plus an amount equal to at least seven and thirty-nine one-hundredths percent of the maintenance of effort base."
