Amend printed bill, strike everything below the enacting clause and substitute the following:

"**SECTION 1.** 26-4-408, Colorado Revised Statutes, is amended BY THE ADDITION OF A NEW SUBSECTION to read:

- **26-4-408. Prescribed drugs.** (3) (a) The state department shall implement drug utilization mechanisms, including, but not limited to, prior authorization, to control costs in the medical assistance program associated with prescribed drugs.
- (b) The state department shall report to the health, environment, welfare, and institutions committees for the house of representatives and the senate and the joint budget committee no later than December 1, 2003, and each December 1 thereafter, on plan utilization mechanisms that have been implemented or that will be implemented by the state department, the time frames for implementation, the expected savings associated with each utilization mechanism, and any other information deemed appropriate by the health, environment, welfare, and institutions committees or the joint budget committee.
- SECTION 2. Appropriation adjustments to 2003 long bill. (1) In addition to any other appropriation, there is hereby appropriated, to the department of health care policy and financing, executive director's office, for the fiscal year beginning July 1, 2003, the sum of one hundred eighteen thousand two hundred twenty-five dollars (\$118,225), for the implementation of this act. Of said sum, twenty-nine thousand five hundred fifty-six dollars (\$29,556) shall be from the general fund and shall be subject to the "(M)" notation as defined in the general appropriation act. In addition to said appropriation, the general assembly anticipates that, for the fiscal year beginning July 1, 2003, the department of health care policy and financing, executive director's office, will receive the sum of eighty-eight thousand six hundred sixty-nine dollars (\$88,669) in federal funds for the implementation of this act. Although the federal funds are not appropriated in this act, they are noted for the purpose of indicating the assumptions used relative to these funds.
- (2) For the implementation of this act, appropriations made in the annual general appropriation act for the fiscal year beginning July 1, 2003, shall be adjusted as follows: The appropriation to the department of health care policy and financing, medical services premiums, is decreased by one million seventy-two thousand nine hundred twelve dollars (\$1,072,912). Of said sum, five hundred thirty-six thousand four hundred fifty-six dollars (\$536,456) shall be from the general fund and five hundred thirty-six thousand four hundred fifty-six dollars (\$536,456) shall be from federal funds.

For all property tax years thereafter, the amount of the exemption for such business personal property shall be equal to the amount of the exemption for the year in which the business personal property was first used.
- (II) THE ECONOMIC STIMULUS VALUE SHALL BE EQUAL TO THE ACTUAL VALUE MULTIPLIED BY NINETY-FIVE PERCENT IN THE TAX YEAR COMMENCING JANUARY 1, 2004, AND FOR EACH PROPERTY TAX YEAR THEREAFTER, SUCH PERCENTAGE SHALL BE REDUCED BY FIVE PERCENTAGE POINTS FROM THE IMMEDIATELY PRECEDING TAX YEAR. FOR ALL TAX YEARS COMMENCING ON AND AFTER JANUARY 1, 2023, THE ECONOMIC STIMULUS VALUE SHALL BE ZERO.
- (III) THE ECONOMIC STIMULUS VALUE SHALL BE USED AS THE ACTUAL VALUE IN DETERMINING WHETHER THE BUSINESS PERSONAL PROPERTY QUALIFIES FOR AN EXEMPTION PURSUANT TO SECTION 39-3-119.5.".
