If an applicant requests renewal of a plan that would extend the plan past five years from the initial date of approval, the applicant shall demonstrate to the water judge in the applicable water division that the delay in obtaining a decree has been justifiable and that not being able to continue operating under a substitute water supply plan until a decree is entered will cause undue hardship to the applicant. ApprovAL OF A PLAN PURSUANT TO SUBSECTION (5) OF THIS SECTION SHALL BE DEEMED TO BE APPROVAL UNDER THIS SUBSECTION (4) FOR PURPOSES OF CALCULATING THE NUMBER OF YEARS SINCE THE INITIAL DATE OF APPROVAL.".

Page 7, line 14, after "(5)", insert "OR ANY WATER USE INCLUDED IN SUCH PLAN".
