**A BILL FOR AN ACT**

101 **CONCERNING THE RIGHT TO DISPLAY THE UNITED STATES FLAG.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)*

Declares that each person has the right to display reasonably the United States flag or other commonly recognized emblems or symbols of the nation or of a person's patriotism:

- On his or her person;
- Anywhere on his or her personal or real property;
- In his or her place of employment;
- In his or her school; and
- In the buildings or on the grounds of any tax-supported property in the state.

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.

*Dashes through the words indicate deletions from existing statute.*

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** Article 2 of title 27, Colorado Revised Statutes, is  
3 amended BY THE ADDITION OF A NEW SECTION to read:

4 **27-2-108.5. Personal display of flags.**

5 (1) THE RIGHT TO DISPLAY REASONABLY THE FLAG OF THE UNITED  
6 STATES SHALL NOT BE INFRINGED WITH RESPECT TO THE DISPLAY:

7 (a) ON HIS OR HER PERSON;

8 (b) ANYWHERE ON HIS OR HER PERSONAL OR REAL PROPERTY; AND

11 (c) IN THE BUILDINGS OR ON THE GROUNDS OF ANY  
12 TAX-SUPPORTED PROPERTY IN THE STATE; EXCEPT THAT THE STATE OR  
13 POLITICAL SUBDIVISION THAT HAS JURISDICTION OVER THE BUILDING OR  
14 GROUNDS MAY ADOPT REASONABLE RULES AND REGULATIONS REGARDING  
15 THE SIZE, NUMBER, PLACEMENT, MANNER OF DISPLAY, AND LIGHTING OF  
16 THE FLAG, AND THE LOCATION, SIZE, AND HEIGHT OF FLAGPOLES.

17 (2) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (1) OF THIS  
18 SECTION TO THE CONTRARY, THE RIGHT WITH RESPECT TO A PERSON'S REAL  
19 PROPERTY SHALL BE SUBJECT TO REASONABLE RESTRICTIVE COVENANTS  
20 OR EQUITABLE SERVITUDES; EXCEPT THAT NO SUCH COVENANT OR  
21 SERVITUDE, NOR ANY OWNERS' ASSOCIATION SHALL PROHIBIT THE  
22 OUTDOOR DISPLAY OF THE FLAG OF THE UNITED STATES BY A PROPERTY  
23 OWNER ON THAT OWNER'S PROPERTY IF THE FLAG IS DISPLAYED IN A  
24 MANNER CONSISTENT WITH CHAPTER 1 OF TITLE 4 OF THE UNITED STATES  
25 CODE, AS AMENDED. AN OWNERS' ASSOCIATION, THE STATE, OR A

1 POLITICAL SUBDIVISION MAY ADOPT REASONABLE RULES AND  
2 REGULATIONS REGARDING THE SIZE, NUMBER, PLACEMENT, MANNER OF  
3 DISPLAY, AND LIGHTING OF THE FLAG, AND THE LOCATION, SIZE, AND  
4 HEIGHT OF FLAGPOLES.

5 (3) FOR PURPOSES OF THIS SECTION, "DISPLAY REASONABLY"  
6 SHALL BE PRESUMED TO INCLUDE A DISPLAY OF THE FLAG OF THE UNITED  
7 STATES THAT IS CONSISTENT WITH CHAPTER 1 OF TITLE 4 OF THE UNITED  
8 STATES CODE, AS AMENDED.

9 (4) A RIGHT DESCRIBED IN SUBSECTION (1) OF THIS SECTION IS A  
10 CIVIL RIGHT OF FREE SPEECH AND A PROTECTED FORM OF EXPRESSION  
11 UNDER THE FIRST AMENDMENT TO THE UNITED STATES CONSTITUTION AND  
12 SECTION 10 OF ARTICLE II OF THE STATE CONSTITUTION.

13 **SECTION 2. Effective date.** This act shall take effect at 12:01  
14 a.m. on the day following the expiration of the ninety-day period after  
15 final adjournment of the general assembly that is allowed for submitting  
16 a referendum petition pursuant to article V, section 1 (3) of the state  
17 constitution; except that, if a referendum petition is filed against this act  
18 or an item, section, or part of this act within such period, then the act,  
19 item, section, or part, if approved by the people, shall take effect on the  
20 date of the official declaration of the vote thereon by proclamation of the  
21 governor.
