After consideration on the merits, the Committee recommends the following:

HB03-1128 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, strike lines 11 through 16 and substitute the
2 following:

3 "(1) (a) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, THE CHIEF
4 ADMINISTRATOR OF A PUBLIC SCHOOL SHALL CAUSE THE NATIONAL MOTTO
5 TO BE PROMINENTLY AND CONSPICUOUSLY DISPLAYED IN A CLASSROOM SO
6 LONG AS A DISPLAY MEETING THE REQUIREMENTS OF PARAGRAPH (c) OF
7 THIS SUBSECTION (1) HAS BEEN DONATED TO THE PUBLIC SCHOOL FOR
8 SUCH PURPOSE; EXCEPT THAT NO MORE THAN ONE DISPLAY PER
9 CLASSROOM SHALL BE REQUIRED.

10 (b) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, THE
11 CHIEF ADMINISTRATIVE OFFICER OF A PUBLIC BUILDING THAT IS UNDER THE
12 AUTHORITY AND CONTROL OF AN INSTITUTION SUPPORTED IN WHOLE OR IN
13 PART BY THE STATE SHALL CAUSE THE NATIONAL MOTTO TO BE
14 PROMINENTLY AND CONSPICUOUSLY DISPLAYED IN A PUBLIC AREA OF THE
15 BUILDING SO LONG AS A DISPLAY MEETING THE REQUIREMENTS OF
16 PARAGRAPH (c) OF THIS SUBSECTION (1) HAS BEEN DONATED TO THE
17 INSTITUTION FOR SUCH PURPOSE; EXCEPT THAT NO MORE THAN ONE
18 DISPLAY PER BUILDING SHALL BE REQUIRED.

1 (c) THE DISPLAY REQUIRED BY THIS SUBSECTION (1)".

2 Page 4, strike lines 1 through 4 and substitute the following:

3 "(2) THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION SHALL
4 NOT APPLY TO ANY STRUCTURE:

5 (a) THAT DOES NOT CONTAIN CLASSROOMS OR OFFICES THAT ARE
6 OPEN FOR BUSINESS WITH THE PUBLIC; OR

7 (b) THAT IS DESIGNED PRIMARILY FOR MAINTENANCE OR FOR
8 VEHICLE PARKING.";

9 strike lines 26 and 27.

10 Page 5, strike lines 1 and 2;

11 line 16, strike "EACH CLASSROOM OF EACH PUBLIC" and substitute
12 "CLASSROOMS OF PUBLIC SCHOOLS";

13 line 17, strike "SCHOOL";

14 strike lines 21 through 25 and substitute the following:

15 "(1) (a) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, THE CHIEF
16 ADMINISTRATIVE OFFICER OF A PUBLIC BUILDING THAT IS UNDER THE
17 AUTHORITY AND CONTROL OF A POLITICAL SUBDIVISION OF THE STATE
18 SHALL CAUSE THE NATIONAL MOTTO TO BE PROMINENTLY AND
19 CONSPICUOUSLY DISPLAYED IN A PUBLIC AREA OF THE BUILDING SO LONG
20 AS A DISPLAY MEETING THE REQUIREMENTS OF PARAGRAPH (b) OF THIS
21 SUBSECTION (1) OF THIS SECTION HAS BEEN DONATED TO THE POLITICAL
22 SUBDIVISION FOR SUCH PURPOSE; EXCEPT THAT NO MORE THAN ONE
23 DISPLAY PER BUILDING SHALL BE REQUIRED.

24 (b)".

25 Page 6, strike lines 10 through 13 and substitute the following:

2 NOT APPLY TO ANY STRUCTURE:

4 BUSINESS WITH THE PUBLIC; OR

5 (b) THAT IS DESIGNED PRIMARILY FOR MAINTENANCE OR FOR
6 VEHICLE PARKING."

7 Page 7, strike lines 8 and 9.
