12 safety, for allocation to the Colorado bureau of investigation, for the
13 fiscal year beginning July 1, 2003, the sum of twenty-four thousand three
14 hundred dollars (\$24,300), or so much thereof as may be necessary, for
15 fingerprint processing services related to the implementation of this act.
16 Of said sum, twenty-one thousand dollars (\$21,000) shall be from cash
17 funds and three thousand three hundred dollars (\$3,300) shall be from
18 cash funds exempt.".

19 Renumber succeeding section accordingly.

20 Page 1, line 103, strike "AGENCIES." and substitute "AGENCIES, AND
21 MAKING AN APPROPRIATION THEREFOR.".
