Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB07-1228 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, strike lines 26 and 27.

2 Strike page 4.

3 Page 5, strike lines 1 through 4.

4 Renumber succeeding sections accordingly.

5 Page 8, strike line 1;

6 before line 2, insert the following:

7 **"SECTION 6. Appropriation - adjustments to the 2007 long**  
8 **bill.** (1) In addition to any other appropriation, there is hereby  
9 appropriated, out of any moneys in the general fund not otherwise  
10 appropriated, to the department of regulatory agencies, for allocation to  
11 the public utilities commission, for the fiscal year beginning July 1, 2007,  
12 the sum of eight thousand four hundred five dollars (\$8,405) and 0.1 FTE,  
13 or so much thereof as may be necessary, for the implementation of this  
14 act.

15 (2) In addition to any other appropriation, there is hereby  
16 appropriated, out of any moneys in the petroleum storage tank fund  
17 created in section 8-20.5-103, Colorado Revised Statutes, not otherwise

1 appropriated, to the department of labor and employment, for allocation  
2 to the division of oil and public safety, for the fiscal year beginning July  
3 1, 2007, the sum of thirty-five thousand six hundred thirty-five dollars  
4 (\$35,635) and 0.5 FTE, or so much thereof as may be necessary, for the  
5 implementation of this act.

6 (3) In addition to any other appropriation, there is hereby  
7 appropriated to the department of law, for the fiscal year beginning July  
8 1, 2007, the sum of one thousand six hundred twenty-five dollars  
9 (\$1,625), or so much thereof as may be necessary, for the provision of  
10 legal services to the department of labor and employment related to the  
11 implementation of this act. Said sum shall be from cash funds exempt  
12 received from the department of labor and employment out of the  
13 appropriation made in subsection (2) of this section.

14 (4) For the implementation of this act, the appropriation made in  
15 section 21 of the annual general appropriation act for the fiscal year  
16 beginning July 1, 2007, shall be adjusted as follows: The general fund  
17 appropriation to the controlled maintenance trust fund is decreased by  
18 eight thousand four hundred five dollars (\$8,405).".

19 Renumber succeeding section accordingly.

20 Page 1, strike lines 102 through 105 and substitute the following:

21 **"REQUIRING THE"**.

22 Amend the transportation & energy committee report dated February 20,  
23 2007, page 4, strike line 30 and substitute the following:

24 **""FUELS, AND MAKING AN APPROPRIATION."."**
