Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB08-1353 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Finance Committee Report, dated March 19, 2008, page 4,
2 after line 28, insert the following:

3 **""SECTION 9. Appropriation - adjustments to the 2008 long**
4 **bill.** (1) In addition to any other appropriation, there is hereby
5 appropriated, out of any moneys in the conservation easement appraisal
6 review fund created in section 12-61-719 (8), Colorado Revised Statutes,
7 not otherwise appropriated, to the department of regulatory agencies, for
8 allocation to the division of real estate, to review conservation easement
9 appraisals, for the fiscal year beginning July 1, 2008, the sum of two
10 hundred thirty-six thousand nine hundred thirty-seven dollars (\$236,937)
11 and 1.8 FTE, or so much thereof as may be necessary, for the
12 implementation of this act.

13 (2) In addition to any other appropriation, there is hereby
14 appropriated, out of any moneys in the conservation easement holder
15 certification fund created in section 12-61-720 (3), Colorado Revised
16 Statutes, not otherwise appropriated, to the department of regulatory
17 agencies, for allocation to the division of real estate, to implement and
18 administer a conservation easement holder certification program, for the
19 fiscal year beginning July 1, 2008, the sum of two hundred thirty-six
20 thousand nine hundred thirty-seven dollars (\$236,937) and 1.8 FTE, or so
21 much thereof as may be necessary, for the implementation of this act.

1 (3) In addition to any other appropriation, there is hereby
2 appropriated, out of any moneys in the general fund not otherwise
3 appropriated, to the department of revenue, for allocation to the taxation
4 business group division, for the review of gross conservation easements,
5 for the fiscal year beginning July 1, 2008, the sum of ninety-two thousand
6 eight hundred eighteen dollars (\$92,818) and 2.0 FTE, or so much thereof
7 as may be necessary, for the implementation of this act."

8 (4) For the implementation of this act, the general fund
9 appropriation to the controlled maintenance trust fund made in section 20
10 of the annual general appropriation act, for the fiscal year beginning July
11 1, 2008, shall be decreased by ninety-two thousand eight hundred
12 eighteen dollars (\$92,818);

13 line 29, strike ""**SECTION 9.**"" and substitute "**SECTION 10.**"".

14 Page 5 of the committee report, line 6, strike "ACT." and substitute
15 "**ACT, AND MAKING AN APPROPRIATION IN CONNECTION**
16 **THEREWITH.**".
