7 line 23, strike "INDIVIDUAL" and substitute "HOME CARE CONSUMER";

8 line 26, strike "INDIVIDUAL'S" and substitute "HOME CARE CONSUMER'S".

9 Page 8, line 2, strike "AN INDIVIDUAL IN THE INDIVIDUAL'S" and substitute
10 "A HOME CARE CONSUMER IN THE HOME CARE CONSUMER'S".

11 Page 9, line 13, after "DEPARTMENT OF", insert "UP TO".

12 Page 10, strike line 1 and substitute the following:

13 "FIVE HUNDRED DOLLARS PER YEAR OR MORE THAN ONE THOUSAND
14 DOLLARS PER YEAR FOR";

15 after line 6, insert the following:

16 "(3) IF A FACILITY THAT IS LICENSED PURSUANT TO THIS TITLE
17 PROVIDES SKILLED HOME HEALTH OR PERSONAL CARE SERVICES ALSO
18 PROVIDES THE SERVICES OUTSIDE THE PREMISES OF THE LICENSED
19 FACILITY, THE FACILITY LICENSE SHALL BE AMENDED TO INCLUDE THE
20 SERVICES AND THE FACILITY SHALL MEET THE REQUIREMENTS
21 PROMULGATED BY THE STATE BOARD."

- 4 Page 14, line 7, strike "PATIENTS" and substitute "HOME CARE
5 CONSUMERS" and, after "PROTECTED.", insert "INSPECTIONS OF A HOME
6 CARE CONSUMER'S HOME SHALL BE SUBJECT TO THE CONSENT OF THE
7 HOME CARE CONSUMER TO ACCESS THE PROPERTY.";
- 8 after line 11, insert the following:
- 9 "(b) THE DEPARTMENT SHALL KEEP ALL MEDICAL RECORDS
10 OBTAINED DURING AN INSPECTION OR INVESTIGATION OF A HOME CARE
11 AGENCY CONFIDENTIAL AND THE MEDICAL RECORDS SHALL BE EXEMPT
12 FROM DISCLOSURE PURSUANT TO SECTIONS 24-72-204, C.R.S., AND
13 25-1-124.".
- 14 Page 15, line 1, strike "PATIENTS" and substitute "HOME CARE
15 CONSUMERS";
- 16 line 9, strike "PATIENTS" and substitute "HOME CARE CONSUMERS";
- 17 line 25, strike "PATIENTS" and substitute "HOME CARE CONSUMERS".
- 18 Page 16, line 22, after "AGENCY", insert "OR HOME CARE PLACEMENT
19 AGENCY" and, after "EMPLOYMENT", insert "OR PLACEMENT".
- 20 Page 19, line 25, strike "PATIENTS" and substitute "HOME CARE
21 CONSUMERS";
- 22 line 26, strike "PATIENTS," and substitute "HOME CARE CONSUMERS,".
- 23 Page 20, line 4, strike "PATIENTS" and substitute "HOME CARE
24 CONSUMERS";
- 25 line 16, strike "PATIENTS" and substitute "HOME CARE CONSUMERS".
