Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB08-153 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 20, after line 3, insert the following:

2           **"SECTION 5. Appropriation.** (1) In addition to any other  
3 appropriation, there is hereby appropriated, out of any moneys in the  
4 home care agency cash fund created in section 25-27.5-105, Colorado  
5 Revised Statutes, not otherwise appropriated, to the department of public  
6 health and environment, for the fiscal year beginning July 1, 2008, the  
7 sum of one hundred eighty-four thousand three hundred eighty-nine  
8 dollars (\$184,389) cash funds, and 2.9 FTE, or so much thereof as may  
9 be necessary, for the implementation of this act. Of said sum, two  
10 thousand eight hundred eighty-one dollars (\$2,881) shall be allocated to  
11 administration and support for the purchase of legal services from the  
12 department of law and one hundred eighty-one thousand five hundred  
13 eight dollars (\$181,508) and 2.9 FTE shall be allocated to the health  
14 facilities and emergency medical services division.

15           (2) In addition to any other appropriation, there is hereby  
16 appropriated, to the department of law, for the fiscal year beginning July  
17 1, 2008, the sum of two thousand eight hundred eighty-one dollars  
18 (\$2,881) or so much thereof as may be necessary, for the provision of  
19 legal services to the department of public health and environment related  
20 to the implementation of this act. Said sum shall be from reappropriated  
21 funds received from the department of public health and environment,  
22 executive director's office out of the appropriation for legal services in  
23 subsection 1 of this section.

1           (3) In addition to any other appropriation, there is hereby  
2 appropriated, to the department of public safety, Colorado bureau of  
3 investigation, for the fiscal year beginning July 1, 2008, the sum of  
4 eighteen thousand one hundred seventy dollars (\$18,170), or so much  
5 thereof as may be necessary, for fingerprint processing services related to  
6 the implementation of this act. Of this sum, ten thousand two hundred  
7 thirty-five dollars (\$10,235) shall be cash funds from fingerprint and  
8 name check processing fees collected by the department, and seven  
9 thousand nine hundred thirty-five dollars (\$7,935) shall be cash funds  
10 from fingerprint and name check processing fees collected by the  
11 department for transmittal to the federal bureau of investigation."

12 Renumber succeeding section according.

13 Page 1, line 102, strike "ENVIRONMENT." and substitute "ENVIRONMENT,  
14 AND MAKING AN APPROPRIATION IN CONNECTION THEREWITH."
