Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB08-219 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 25, before line 26, insert the following:

2           **"SECTION 6. Appropriation.** (1) In addition to any other  
3 appropriation, there is hereby appropriated, out of any moneys in the  
4 division of registrations cash fund created in section 24-34-105 (2) (b) (I),  
5 Colorado Revised Statutes, not otherwise appropriated, to the department  
6 of regulatory agencies, for allocation to the executive director's office, for  
7 legal services, for the fiscal year beginning July 1, 2008, the sum of  
8 eighteen thousand eight dollars (\$18,008), or so much thereof as may be  
9 necessary, for the implementation of this act.

10           (2) In addition to any other appropriation, there is hereby  
11 appropriated, out of any moneys in the division of registrations cash fund  
12 created in section 24-34-105 (2) (b) (I), Colorado Revised Statutes, not  
13 otherwise appropriated, to the department of regulatory agencies, for  
14 allocation to the division of registrations, for regulation of massage  
15 therapists, for the fiscal year beginning July 1, 2008, the sum of two  
16 hundred twenty-eight thousand eighty dollars (\$228,080) and 3.3 FTE, or  
17 so much thereof as may be necessary, for the implementation of this act.

18           (3) In addition to any other appropriation, there is hereby  
19 appropriated to the department of regulatory agencies, for allocation to  
20 the division of registrations, for the fiscal year beginning July 1, 2008, the  
21 sum of two hundred twenty-three thousand six hundred dollars  
22 (\$223,600), or so much thereof as may be necessary, for pass through to

1 the department of public safety, to perform criminal history background  
2 checks for massage therapists related to the implementation of this act.  
3 Said sum shall be from application processing fees collected by the  
4 division of registrations.

5 (4) In addition to any other appropriation, there is hereby  
6 appropriated to the department of law, for the fiscal year beginning July  
7 1, 2008, the sum of eighteen thousand eight dollars (\$18,008) and 0.2  
8 FTE, or so much thereof as may be necessary, for the provision of legal  
9 services to the department of regulatory agencies related to the  
10 implementation of this act. Said sum shall be from reappropriated funds  
11 received from the executive director's office out of the appropriation  
12 made in subsection (1) of this section.

13 (5) In addition to any other appropriation, there is hereby  
14 appropriated, to the department of public safety, for allocation to the  
15 Colorado bureau of investigation, for processing of fingerprint-based  
16 criminal history background checks for massage therapists, for the fiscal  
17 year beginning July 1, 2008, the sum of one hundred twenty thousand one  
18 hundred dollars (\$120,100) and 1.1 FTE, or so much thereof as may be  
19 necessary, for the implementation of this act. Said sum shall be from  
20 reappropriated funds received from the department of regulatory  
21 agencies, division of registrations, out of the appropriation made in  
22 subsection (3) of this section.

23 (6) In addition to any other appropriation, there is hereby  
24 appropriated to the department of public safety, for the fiscal year  
25 beginning July 1, 2008, the sum of one hundred three thousand five  
26 hundred dollars (\$103,500), or so much thereof as may be necessary, for  
27 pass through to the federal bureau of investigation for fingerprint-based  
28 national criminal history background checks for massage therapists  
29 related to the implementation of this act. Said sum shall be from  
30 reappropriated funds received from the department of regulatory  
31 agencies, division of registrations, out of the appropriation made in  
32 subsection (3) of this section."

33 Renumber the succeeding section accordingly.

34 Page 1, line 101, strike "**THERAPISTS.**" and substitute "**THERAPISTS, AND**  
35 **MAKING AN APPROPRIATION THEREFOR.**".
