Summary of Legislation

This bill requires health insurance coverage for medically appropriate hearing aids for minor children whose hearing loss is verified by a physician or audiologist. These benefits are subject to the same annual deductibles or copayments established for all health insurance covered benefits and to utilization review. Coverage includes:

- ▶ initial hearing aids and replacement hearing aids, but not more often than every five years;
- ▶ a new hearing aid when alterations to the existing appliance cannot adequately meet the needs of the child; and
- ▶ services and supplies including but not limited to the initial assessment, fitting, adjustments, and auditory training.

Background

According to the Department of Education's 2006 Survey of Educational Audiologists, about 2 percent of Colorado school children have a hearing loss. Of those, about 9 percent use hearing aids. This shows that .18 percent of Colorado school children use at least one hearing aid. The fiscal note assumes this percentage is representative of all Colorado children aged 0 to 18.

State Expenditures

This bill has a fiscal impact of approximately \$54,300 for FY 2008-09 and \$116,800 for FY 2009-10 for the Department of Health Care Policy and Financing. For FY 2008-09, costs are split between the General Fund (\$19,000) and federal funds (\$35,300).

Department of Health Care Policy and Financing — will have an increase in expenditures in the Children's Basic Health Plan which is administered as an insurance plan rather than an entitlement program. The plan currently limits annual benefits for hearing aids to \$800 when the average cost is approximately \$1,300 per child. The bill requires an increase of \$0.13 per member, per month for 62,481 children in FY 2008-09 and 65,899 in FY 2009-10. Because of the January 1, 2009, effective date, for FY 2008-09, costs of \$54,300 reflect only six months of implementation. For FY 2009-10, the first full year of implementation, costs are \$116,800. The bill has no effect on Medicaid services.

State Employee Health Plan Contributions. The bill applies to the health insurance plans offered to state employees under the state's employee benefit program. Total health plan cost increases are expected to translate into increased annual premiums of \$36,580 spread across all enrolled state employees and dependents. The increases per policy range from \$0.03 per month for employee only coverage, to \$0.18 per month for employee and family coverage beginning in FY 2009-10.

State Employer Health Plan Contributions. While premium increases are expected to be paid by state employees in the first year, this bill may influence the General Assembly to increase the state's contribution in order to meet the statutory requirement of providing benefits comparable to private sector employers. Over time, increased health insurance premiums would be incorporated into the Total Compensation Survey, and any increases to the state's contribution to maintain parity with the private sector will increase state expenditures.

Local Government Impact

An increase in premiums for health insurance at the local level is likely given the increase in benefits. The size of the increase and who will bear the expense, cannot be determined.
