HOUSE JOINT RESOLUTION 08-1042

101 CONCERNING THE PRIORITIZED LIST OF PROJECTS FOR WHICH THE
102 STATE TREASURER IS AUTHORIZED TO ENTER INTO
103 LEASE-PURCHASE AGREEMENTS.

1 WHEREAS, Pursuant to section 23-29.9-102, Colorado Revised
2 Statutes, as enacted in Senate Bill 08-218, enacted in the Second Regular
3 Session of the Sixty-sixth General Assembly, the higher education federal
4 mineral lease revenues fund ("revenues fund") was created to provide
5 funding for capital construction projects at state-supported institutions of
6 higher education; and

7 WHEREAS, Pursuant to section 23-1-106.3, Colorado Revised
8 Statutes, as enacted in Senate Bill 08-233, enacted in the Second Regular
9 Session of the Sixty-sixth General Assembly, the Colorado Commission
10 on Higher Education and the Office of State Planning and Budgeting have
11 submitted to the Capital Development Committee prioritized lists of
12 capital construction projects at state-supported institutions of higher
13 education that are appropriate for lease-purchase agreements to be funded
14 from the revenues fund; and

1 WHEREAS, The Capital Development Committee has reviewed
2 the prioritized lists and submitted to the Joint Budget Committee its
3 prioritized list of capital construction projects at state-supported
4 institutions of higher education that are appropriate for lease-purchase
5 agreements to be funded from the revenues fund; and

6 WHEREAS, Pursuant to section 23-1-106.3, Colorado Revised
7 Statutes, the Joint Budget Committee is directed to sponsor a Joint
8 Resolution identifying a prioritized list of capital construction projects at
9 state-supported institutions of higher education that are appropriate for
10 lease-purchase agreements to be funded from the revenues fund; and

11 WHEREAS, Pursuant to section 23-1-106.3, Colorado Revised
12 Statutes, the State Treasurer is authorized to enter into lease-purchase
13 agreements on projects in accordance with the prioritized list contained
14 in this Joint Resolution, subject to the limitations contained in section
15 23-1-106.3, Colorado Revised Statutes; now, therefore,

16 *Be It Resolved by the House of Representatives of the Sixty-sixth*
17 *General Assembly of the State of Colorado, the Senate concurring herein:*

18 (1) That the following prioritized list contains the name of the
19 institution, the name of the project, the principal amount of money to be
20 raised through lease-purchase agreements to be paid from the revenues
21 fund, the principal amount of money that the institution is to contribute
22 to the project, and the total anticipated cost of the project:

1 (2) The State Treasurer is authorized to enter into lease-purchase
2 agreements according to the list specified in subsection (1) of this Joint
3 Resolution but only to the extent that funding for the projects is available;
4 except that, if there is insufficient money available to fully fund that last
5 project on the list for which funding is available, the State Treasurer is
6 authorized to enter into a lease-purchase agreement for the next project
7 or projects on the list for which there is sufficient money to fully fund the
8 project.

9 *Be It Further Resolved*, That this Joint Resolution be presented to
10 the Governor for signature pursuant to section 23-1-106.3, Colorado
11 Revised Statutes.
