Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB08-1402 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Business Affairs and Labor Committee Report, dated April  
2 24, 2008, page 2, line 8, strike "**administration.**" and substitute  
3 "**administration - repeal.**";

4 line 14, strike "ANY" and substitute "THE 2008-09";

5 line 15, after the period, add "ANY UNEXPENDED AND UNENCUMBERED  
6 MONEYS REMAINING IN THE FUND AS OF JUNE 30, 2010, SHALL REVERT TO  
7 THE GENERAL FUND."

8 Page 3, after line 8, insert the following:

9 "(4) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2010.";

10 strike lines 9 through 21 and insert the following:

11 "**SECTION 3. Appropriation - adjustments to the 2008 long**  
12 **bill.** (1) In addition to any other appropriation, there is hereby  
13 appropriated, out of any moneys in the general fund not otherwise  
14 appropriated, to the foreclosure prevention grant fund created in section  
15 24-32-719 (1), Colorado Revised Statutes, for the fiscal year beginning  
16 July 1, 2008, the sum of one hundred thousand dollars (\$100,000), or so  
17 much thereof as may be necessary, for the implementation of this act.

1           (2) In addition to any other appropriation, there is hereby  
2 appropriated, out of any moneys in the foreclosure prevention grant fund  
3 created in section 24-32-719 (1), Colorado Revised Statutes, not  
4 otherwise appropriated, to the department of local affairs, for allocation  
5 to the division of housing, for the fiscal years beginning July 1, 2008 and  
6 July 1, 2009, the sum of one hundred thousand dollars (\$100,000), or so  
7 much thereof as may be necessary, for the implementation of this act.

8           (3) For the implementation of this act, the general fund  
9 appropriation to the controlled maintenance trust fund made in section 23  
10 of the annual general appropriation act, for the fiscal year beginning July  
11 1, 2008, shall be decreased by one hundred thousand dollars (\$100,000).";

12 After line 21 of the Committee Report, insert the following:

13 "Page 1, line 102, strike **""FORECLOSURE."** and substitute  
14 **"FORECLOSURE, AND MAKING AN APPROPRIATION THEREFOR."**".
