## **Bill Summary**

Legislative Emergency Epidemic Response Committee. Allows the general assembly, upon declaration by the governor of a disaster emergency based upon an emergency epidemic, to convene any regular or special session, at any time or date deemed necessary, in either a location other than the state capitol building within the city and county of Denver or, if necessary, a location outside of the city and county of

2	SECTION 1. Part 15 of article 3 of title 2, Colorado Revised

7	(1) (a) THE GENERAL ASSEMBLY HEREBY FINDS AND DETERMINES THAT
8	IN THE EVENT OF AN EMERGENCY EPIDEMIC, THE GENERAL ASSEMBLY MAY
9	NEED TO CONDUCT ITS BUSINESS SO AS NOT TO FURTHER SPREAD
10	COMMUNICABLE DISEASES, WORSEN THE EMERGENCY EPIDEMIC, OF
11	NEEDLESSLY ENDANGER THE MEMBERS OR LEGISLATIVE STAFF.
12	(b) The general assembly declares that:
13	(I) THE PURPOSE OF THE PROCESS OUTLINED IN THIS SECTION IS TO
14	ALLOW FOR THE GENERAL ASSEMBLY TO CARRY OUT ITS ESSENTIAL
15	BUSINESS WITHOUT VIOLATING THE CONSTITUTIONAL REQUIREMENTS

17	(II) THE PROCESSES OUTLINED IN THIS SECTION THAT ARE TO BE
18	FOLLOWED IN THE EVENT OF AN EMERGENCY EPIDEMIC ARE ONLY OF A

20	(III) TAKING SUCH MEASURES WITH RESPECT TO HAVING A
