## A BILL FOR AN ACT

CONCERNING CONTINUATION OF PROVISIONS RELATED TO THE FIRE SERVICE TRAINING AND CERTIFICATION ADVISORY BOARD.

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Sunset Process - Senate Judiciary Committee. Continues the fire service training and certification advisory board in the division of fire safety within the office of preparedness, security, and fire safety in the department of public safety (department), under the provisions of the sunset law. Changes the statutory reference to the department's emergency medical services and prevention division, which no longer exists, to the emergency medical and trauma services section within the

health facilities and emergency medical services division of the department.
