After consideration on the merits, the Committee recommends the following:

HB09-1230 be amended as follows:

1 Amend reegrossed bill, page 4, after line 7, insert the following:

2 "SECTION 4. 40-7-113, Colorado Revised Statutes, is amended  
3 BY THE ADDITION OF A NEW SUBSECTION to read:

4 **40-7-113. Civil penalties - fines.** (5) ANY PERSON WHO FAILS TO  
5 PAY IN FULL ALL CIVIL PENALTIES FOR A SECOND OR SUBSEQUENT  
6 VIOLATION ASSESSED BY COMMISSION ORDER PURSUANT TO THIS SECTION,  
7 SUBJECT TO ALL APPLICABLE PROVISIONS OF ARTICLE 4 OF TITLE 24,  
8 C.R.S., WITHIN THIRTY DAYS OF THE DUE DATE ESTABLISHED BY SUCH  
9 ORDER MAY BE SUBJECT TO HAVE HIS OR HER VEHICLE REGISTRATION  
10 CANCELLED BY THE DEPARTMENT OF REVENUE AS SPECIFIED IN SECTION  
11 42-3-120 (4), C.R.S. REGISTRATION OF ANY VEHICLES OWNED BY SUCH  
12 PERSON FOR WHICH THE PENALTY WAS ASSESSED MAY BE DENIED UNTIL  
13 ALL PENALTIES ARE PAID OR COLLECTED. UPON WRITTEN NOTICE FROM  
14 THE COMMISSION, THE DEPARTMENT OF REVENUE SHALL CANCEL SUCH  
15 REGISTRATION AS SPECIFIED IN SECTION 42-3-120 (4), C.R.S.

16 **SECTION 5.** 42-3-120, Colorado Revised Statutes, is amended  
17 BY THE ADDITION OF A NEW SUBSECTION to read:

18 **42-3-120. Department may cancel or deny registration -**  
19 **repeal.** (4) UPON RECEIVING WRITTEN NOTICE FROM THE PUBLIC  
20 UTILITIES COMMISSION THAT A PERSON HAS FAILED TO TIMELY PAY CIVIL  
21 PENALTIES IMPOSED IN ACCORDANCE WITH SECTION 40-7-113, THE  
22 DEPARTMENT SHALL CANCEL THE REGISTRATION OF ANY VEHICLE THAT IS



1 OWNED BY THE PERSON FOR WHICH THE PENALTY WAS ASSESSED AND  
2 SHALL DENY THE REGISTRATION OF ANY SUCH VEHICLE UNTIL THE  
3 DEPARTMENT RECEIVES WRITTEN NOTICE THAT THE PENALTY HAS BEEN  
4 PAID IN FULL."
