Section 33-1-105 (3)(a), C.R.S. states:

In the event that the [Wildlife] Commission plans to acquire the fee title to any real property or to acquire an easement for a period to exceed 25 years or at a cost to exceed \$100,000 or to enter into any lease agreement for the use of real property for a period to exceed 25 years or at a cost to exceed \$100,000, or to sell or otherwise dispose of the fee title to any real property which has a market value in excess of \$100,000, the Commission shall first submit a report to the Capital Development Committee [CDC] which outlines the anticipated use of the real property, the maintenance costs related to the property, the current value of the property, any conditions or limitations which may restrict the use of the property, and, in the event real property is acquired, the potential liability to the state which will result from such acquisition. The CDC shall review the reports submitted by the Commission and make recommendations to the Commission concerning the proposed land transaction within 30 days from the day on which the report is received. The Commission shall not complete such transaction without considering the recommendations of the CDC, if such recommendations are timely made.

The required report is attached. CDC staff's questions about the report are listed below.

Action Required

Recommend support for the Cabin Creek State Wildlife Area (202 acres) and Lost Canyon State Wildlife Area (305-320 acres) donation.

CDC Staff Questions

1. When does the division anticipate that the Van Tuyl Estate will be settled and title to the two properties will be conferred to the state?

It is our understanding that the property transfer will occur by sometime in November 2009 at the latest. In the event that all parties named as legatees under the will agree to settlements prior to then, the closing could occur at any time thereafter. Similarly, if the Court, absent agreement of all parties, makes a Decree of Distribution, the closing could occur at any time thereafter. At present, lack of agreement by the parties will result in a court hearing and decision sometime in October 2009.

Summary of Proposal

Raymond Van Tuyl, a long-time Gunnison rancher, died in 2008. In his will, Van Tuyl bequeathed \$1,000,000 to the Division of Wildlife for "the purposes of wildlife propagation and for the development of Wilson Creek . . . into a fishery." The will has been contested. The Division of Wildlife is willing to accept a settlement offer of two parcels of land held in Van Tuyl's estate (Cabin Creek and Lost Canyon) in lieu of the monetary bequest. This settlement would free the remaining assets of the estate for distribution among the other identified parties, including Pioneer Museum, Elks Club, Gunnison County, Gunnison County 4-H Club, Gunnison County High School Agricultural program and other named individuals and entities.

Both parcels are almost completely surrounded by either Bureau of Land Management or United States Forest Service lands. Both have access via county or BLM roads. The properties are areas of critical winter range for deer and elk, and also are habitat for Gunnison sage grouse. The close proximity to Gunnison makes these properties vulnerable to development which would fragment the big game and Gunnison sage grouse habitat. Cabin Creek has been used twice as a

big game feed site during severe winters. Acceptance of this donation would preserve more than 500 acres of land delineated for protection on the 2009 High Priority Habitat-Acquisition Areas map.

Because this is a fee title donation, the policies of the Division of Wildlife would determine any development of any wind, solar, geothermal, mineral, or any other resources which may be on the property. According to the maps referenced below, the Property generally lies outside the scope of potential Wind, Solar, and Geothermal energy potential.



Mineral potential is unknown because a mineral assessment has not yet been performed, although the title commitment indicates that on all of the property, there is only one mineral reservation in Section 12 and one mineral reservation in Section 8.


