HB09-1202 be amended as follows:

- 1 Amend reengrossed bill, page 3, line 11, strike "WHO IS";
- 2 line 16, strike "body. for compensation." and substitute "body for
- 3 compensation.";
- 4 line 23, strike "or" and substitute "or AND".
- 5 Page 4, after line 3, insert the following:
 - 6 "(14.5) "IMPLANTED DEVICE" MEANS A MECHANICAL DEVICE THAT
 - 7 MAY EXPLODE OR CAUSE DAMAGE TO CREMATORY EQUIPMENT.";
 - 8 line 5, strike "who for compensation;" and substitute "who, for
 - 9 compensation,".
- 10 Page 6, strike lines 5 through 7 and substitute the following:
 - 11 "(VIII) IS A TECHNICIAN REPRESENTING A PROCUREMENT
 - 12 ORGANIZATION AS DEFINED IN SECTION 12-34-102 FOR PURPOSES OF AN
 - 13 ANATOMICAL GIFT; OR".
- 14 Page 7, line 3, strike "The" and substitute "12-54-108 (3), the" and, after
- 15 "(4)", insert a comma;
- 16 strike line 5 and substitute the following:



1 **"12-54-108. Exceptions - safe harbor.** (3) Any A person who
2 provides the sole service of selling or offering for sale SELLS OR OFFERS
3 TO SELL caskets, URNS, OR OTHER FUNERAL GOODS, BUT DOES NOT
4 PROVIDE FUNERAL SERVICES, shall not be subject to the provisions of this
5 article.

7 Page 9, line 5, strike "OR" and substitute "AND".

8 Page 14, strike lines 18 through 20 and substitute the following:

9 "(VIII) IS A TECHNICIAN REPRESENTING A PROCUREMENT
10 ORGANIZATION AS DEFINED IN SECTION 12-34-102 FOR PURPOSES OF AN
11 ANATOMICAL GIFT; OR".

12 Page 17, line 22, strike "GOODS OR" and substitute "GOODS AND".

13 Page 19, line 24, strike "ONE HUNDRED" and substitute "FIFTY".

14 Page 27, afer line 13, insert the following:

15 "(c) BEFORE PROMULGATING RULES, THE DIRECTOR MAY SEEK
16 INPUT AND ADVICE FROM A CONSUMER REPRESENTATIVE WHO ADVOCATES
17 FOR CONSUMERS AFFECTED BY THIS ARTICLE.".
