After consideration on the merits, the Committee recommends the following:

SB09-024 be amended as follows:

- 1 Amend proposed committee amendment, (SB024\_L.008), page 3, line 4,  
 2 after "(a)", insert "(I)";
- 3 line 5, after "APPROPRIATE", insert "TEMPORARY";
- 4 after line 6, insert the following:
- 5           "(II) PERMANENT GAME DAMAGE PREVENTION MATERIALS SHALL  
 6 BE AVAILABLE ONLY TO A LANDOWNER:
- 7           (A) WHO CHARGES NOT MORE THAN ONE HUNDRED DOLLARS PER  
 8 PERSON, PER SEASON, FOR BIG GAME HUNTING ACCESS ON OR ACROSS THE  
 9 LANDOWNER'S PROPERTY; OR
- 10           (B) WHO CHARGES A FEE IN EXCESS OF ONE HUNDRED DOLLARS  
 11 PER PERSON, PER SEASON, FOR BIG GAME HUNTING ACCESS ON OR ACROSS  
 12 THE LANDOWNER'S PROPERTY, IF THE LANDOWNER HAS REQUESTED AND  
 13 BEEN DENIED GAME DAMAGE PREVENTION MATERIALS FROM THE HABITAT  
 14 PARTNERSHIP PROGRAM CREATED IN SECTION 33-1-110 (8) AND THE  
 15 DIVISION DETERMINES THAT EXCESSIVE GAME DAMAGE IS OCCURRING,  
 16 AND MAY CONTINUE TO OCCUR IN THE FUTURE.";
- 17 line 19, strike "SUCH" and substitute "TEMPORARY GAME DAMAGE  
 18 PREVENTION";
- 19 strike line 21;



1 after line 22, insert the following:

2 "(II) FOR A LANDOWNER ELIGIBLE TO RECEIVE PERMANENT GAME  
3 DAMAGE PREVENTION MATERIALS PURSUANT TO SUBPARAGRAPH (II) OF  
4 PARAGRAPH (a) OF THIS SUBSECTION (2), SUCH MATERIALS SHALL BE  
5 PROVIDED WITHIN FORTY-FIVE DAYS AFTER THE DATE THAT THE  
6 LANDOWNER MAKES THE INITIAL REQUEST FOR THE MATERIALS.";

7 strike lines 23 through 28.

8 Page 5, strike lines 1 through 17.

9 Renumber succeeding section accordingly.
