After consideration on the merits, the Committee recommends the following:

HB09-1137 be amended as follows:

1 Amend printed bill, page 3, after line 15, insert the following:

2           "(j) THE PEOPLE OF THE STATE AND THE ESSENTIAL FUNCTIONS OF  
3 STATE GOVERNMENT ARE ADVERSELY AFFECTED WHEN THE WINNINGS OF  
4 AN INDIVIDUAL WHO IS INDEBTED TO THE STATE ARE NOT APPLIED TO THE  
5 DEBTOR'S OBLIGATIONS TO THE STATE."

6 Page 4, line 3, strike "AND";

7 strike line 6 and substitute the following:

9           (e) UNPAID DEBT OWED TO THE STATE THAT IS SUBJECT TO

12 after line 23, insert the following:

13           "(2.7) UPON CERTIFICATION BY THE APPROPRIATE STATE AGENCY  
14 OF THE AMOUNT OF THE DEBT DUE THE STATE, THE STATE CONTROLLER,  
15 THROUGH THE CENTRAL COLLECTION SERVICES SECTION OF THE DIVISION  
16 OF FINANCE AND PROCUREMENT, OR ANY SUCCESSOR SECTION, IN THE  
17 DEPARTMENT OF PERSONNEL, SHALL ENTER IN THE REGISTRY OR CERTIFY  
18 TO THE REGISTRY OPERATOR THE INFORMATION CONTAINED IN  
19 SUBSECTION (4) OF THIS SECTION REGARDING EACH PERSON WITH AN

- 1 UNPAID DEBT AS SPECIFIED IN SECTION 24-35-603 (2) (e).";
- 2 line 26 strike "AND" and strike "REVENUE" and substitute "REVENUE, AND
- 3 THE CENTRAL COLLECTION SERVICES SECTION";
- 4 line 27, strike "AND (2.5)" and substitute "(2.5), AND (2.7)".

  - 22 CERTIFIED BY THE SECTION.";

- 27 PERSONNEL".

5 SERVICES SECTION OF THE DIVISION OF FINANCE AND PROCUREMENT, OR  
6 ANY SUCCESSOR SECTION, IN THE DEPARTMENT OF PERSONNEL";

7 line 13, strike "DEPARTMENT AND" and substitute "DEPARTMENT,";

8 line 14, strike "services" and substitute "services, AND THE CENTRAL  
9 COLLECTION SERVICES SECTION OF THE DIVISION OF FINANCE AND  
10 PROCUREMENT, OR ANY SUCCESSOR SECTION, IN THE DEPARTMENT OF

13 line 104, strike "TAXES" and substitute "TAXES, AND OTHER STATE  
14 DEBTS".
