After consideration on the merits, the Committee recommends the following:

SB09-031 be amended as follows:

- 1 Amend reengrossed bill, page 6, line 11, strike "IF THE COLORADO";
- 2 strike lines 12 through 16.
- 3 Page 9, line 17, strike "FROM" and substitute "PURSUANT TO PARAGRAPH
- 4 (b) OR (c) OF THIS SUBSECTION (5).";
- 5 strike line 18;
- 6 line 19, strike "SECTION 25-17-202 (1) (a) (V), C.R.S.".
- 7 Page 10, after line 3, insert the following:
 - 8 "(b) THE COLORADO OFFICE OF ECONOMIC DEVELOPMENT IS
 - 9 AUTHORIZED TO SEEK AND ACCEPT GIFTS, GRANTS, OR DONATIONS FROM
 - 10 PRIVATE OR PUBLIC SOURCES FOR THE PURPOSES OF THIS ARTICLE; EXCEPT
 - 11 THAT THE DEPARTMENT SHALL NOT ACCEPT A GIFT, GRANT, OR DONATION
 - 12 IF IT IS SUBJECT TO CONDITIONS THAT ARE INCONSISTENT WITH THIS
 - 13 ARTICLE OR ANY OTHER LAW OF THE STATE. THE COLORADO OFFICE OF
 - 14 ECONOMIC DEVELOPMENT SHALL TRANSMIT ALL PRIVATE AND PUBLIC
 - 15 MONEYS RECEIVED THROUGH GIFTS, GRANTS, OR DONATIONS TO THE
 - 16 STATE TREASURER, WHO SHALL CREDIT THE SAME TO THE FUND.
- 17 (c) TO THE EXTENT PERMITTED BY LAW, THE GOVERNOR, AT HIS OR
- 18 HER DISCRETION, OR THE COLORADO OFFICE OF ECONOMIC DEVELOPMENT,
- 19 AT ITS DISCRETION, MAY DIRECT OTHER MONEYS TO THE FUND FOR THE



- 1 PURPOSES OF THIS ARTICLE."
- 2 Reletter succeeding paragraph accordingly.
- 3 Page 10, strike lines 8 through 27.
- 4 Page 11, strike lines 1 through 6.
- 5 Renumber succeeding section accordingly.
- 6 Page 1, line 102, strike "PROGRAM, AND MAKING AN" and substitute
- 7 "PROGRAM.";
- 8 strike line 103.
