After consideration on the merits, the Committee recommends the following:

SB09-003 be amended as follows:

1 Amend printed bill, page 2, line 2, strike "and (20)," and substitute "(20)
2 (a) (I), (20) (a) (II), (20) (a) (III), (20) (a) (IV), (20) (b), (20) (c), and (20)
3 (d),".

4 Strike page 5.

5 Page 6, strike lines 1 through 22;

6 line 24, strike everything after "the" and substitute "counties of El Paso
7 Larimer, and Weld".

8 Page 7, line 1, strike "LARIMER, AND WELD," and substitute "AND
9 LARIMER,";

10 after line 18, insert the following:

11 "SECTION 2. 42-4-304 (20) (a) (V), Colorado Revised Statutes,
12 is amended to read:

13 **42-4-304. Definitions relating to automobile inspection and**
14 **readjustment program.** As used in sections 42-4-301 to 42-4-316,
15 unless the context otherwise requires:

16 (20) (a) "Program area" means the counties of Adams, Arapahoe,
17 Boulder, Douglas, El Paso, Jefferson, Larimer, and Weld, and the cities
18 and counties of Broomfield and Denver, excluding the following areas
19 and subject to paragraph (d) of this subsection (20):



1 (V) That portion ~~THOSE PORTIONS~~ of Weld county which is
2 outside ~~THAT ARE WITHIN~~ the corporate boundaries of Greeley, Evans, La
3 Salle, and Garden City, and, in addition, is outside the following
4 boundary: Beginning at the point of intersection of the west boundary line
5 of section 21, township six north, range sixty-six west and state highway
6 392, east along state highway 392 to the point of intersection with Weld
7 county road 37; then south along Weld county road 37 to the point of
8 intersection with Weld county road 64; then east along Weld county road
9 64 to the point of intersection with Weld county road 43; then south along
10 Weld county road 43 to the point of intersection with Weld county road
11 62; then east along Weld county road 62 to the point of intersection with
12 Weld county road 49; then south along Weld county road 49 to the point
13 of intersection with the south boundary line of section 13, township five
14 north, range sixty-five west; then west along the south boundary line of
15 section 13, township five north, range sixty-five west, section 14,
16 township five north, range sixty-five west, and section 15, township five
17 north, range sixty-five west; then, from the southwest corner of section
18 15, township five west, range sixty-five west, south along the east
19 boundary line of section 21, township five north, range sixty-five west,
20 and section 28, township five north, range sixty-five west; then west
21 along the south boundary line of section 28, township five north, range
22 sixty-five west; then south along the east boundary line of section 32;
23 township five north, range sixty-five west, and section 5, township four
24 north, range sixty-five west; then west along the south boundary line of
25 section 5, township four north, range sixty-five west, section 6, township
26 four north, range sixty-five west, and section 1, township four north,
27 range sixty-six west; then north along the west boundary line of section
28 1, township four north, range sixty-six west, and section 36, township five
29 north, range sixty-six west; then, from the point of intersection of the west
30 boundary line of section 36, township five north, range sixty-six west and
31 Weld county road 52, west along Weld county road 52 to the point of
32 intersection with Weld county road 27; then north along Weld county
33 road 27 to the point of intersection with the south boundary line of section
34 18, township five north, range sixty-six west; then west along the south
35 boundary line of section 18, township five north, range sixty-six west,
36 section 13, township five north, range sixty-seven west, and section 14,
37 township five north, range sixty-seven west; then north along the west
38 boundary line of section 14, township five north, range sixty-seven west,
39 section 11, township five north, range sixty-seven west, and section 2,
40 township five north, range sixty-seven west; then east along the north



1 boundary line of section 2, township five north, range sixty-seven west,
2 section 1, township five north, range sixty-seven west, section 6,
3 township five north, range sixty-six west, and section 5, township five
4 north, range sixty-six west; then, from the northeast corner of section 5,
5 township five north, range sixty-six west, north along the west boundary
6 line of section 33, township six north, range sixty-six west, section 28,
7 township six north, range sixty-six west, and section 21, township six
8 north, range sixty-six west, to the point of beginning WINDSOR,
9 JOHNSTOWN, MILLIKEN, BERTHOUD, MEAD, LONGMONT, FIRESTONE,
10 FREDERICK, FORT LUPTON, DACANO, ERIE, NORTHGLENN, LOCHBUIE,
11 AND BRIGHTON.

12 **SECTION 3.** 42-4-304 (20) (b) and (20) (c) (I), Colorado Revised
13 Statutes, as amended by Senate Bill 09-003, enacted at the First Regular
14 Session of the Sixty-seventh General Assembly, are amended to read:

15 **42-4-304. Definitions relating to automobile inspection and**
16 **readjustment program.** As used in sections 42-4-301 to 42-4-316,
17 unless the context otherwise requires:

18 (20) (b) ~~Effective January 1, 2010~~ UPON THE EFFECTIVE DATE OF
19 THIS PARAGRAPH (b), AS AMENDED, the basic emissions program area
20 shall consist of the counties COUNTY of El Paso and Weld as described in
21 paragraph (a) of this subsection (20).

22 (c) (I) ~~Effective January 1, 2010~~ UPON THE EFFECTIVE DATE OF
23 THIS SUBPARAGRAPH (I), AS AMENDED, the enhanced emissions program
24 area shall consist of the counties of Adams, Arapahoe, Boulder, Douglas,
25 Jefferson, and Larimer, AND WELD, and the cities and counties of
26 Broomfield and Denver as described in paragraph (a) of this subsection
27 (20) and subject to paragraph (d) of this subsection (20)."

28 Renumber succeeding sections accordingly.

29 Page 13, strike lines 18 through 20 and substitute the following:

30 **"SECTION 10. Effective date - applicability.** (1) Except as
31 otherwise provided in subsection (2) of this section, this act shall take
32 effect upon passage and shall apply to motor vehicles registered as
33 collector's items on or after the effective date of this act.



1 (2) Sections 2 and 3 of this act shall take effect January 1, 2011,
2 only if, prior to that date, the air quality control commission in the
3 department of public health and environment notifies the revisor of
4 statutes in writing that the three-year moving average of the fourth
5 maximum for ozone levels in Weld county, as determined by emissions
6 data at the Greeley/Weld monitor for the calendar years 2007, 2008, and
7 2009, demonstrate that Weld county has exceeded .75 parts per billion
8 (ppb).".
