line 9, strike "24-33-113 (2)" and substitute "24-33-111 (2)";

after line 10, insert the following:

"line 13 of the printed bill, after the period, add "IF POSSIBLE, SUCH REPORT SHALL BE MADE AT THE SAME TIME AS THE REPORT DESCRIBED IN SECTION 24-33-111 (3) (a).";".

**SECTION 4. Appropriation.** In addition to any other appropriation, there is hereby appropriated, out of any moneys in the operation and maintenance account of the species conservation trust fund created in section 24-33-111 (2) (a) (I), Colorado Revised Statutes, not otherwise appropriated, to the department of natural resources, executive director's office, for personal services, for the fiscal year beginning July 1, 2009, the sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, for the implementation of this act.";

strike lines 25 through 27 of the printed bill and substitute the following:

"SECTION 5. Act subject to petition - effective date. (1) Except as otherwise provided in subsection (2), this act shall take effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly that is allowed for submitting a referendum petition pursuant to article V, section 1 (3) of the state constitution, (August 4, 2009, if adjournment sine die is on May 6, 2009); except that, if a referendum petition is filed against this act or an item, section, or part of this act within such period, then the act, item, section, or part, if approved by the people, shall take effect on the date of the official declaration of the vote thereon by proclamation of the governor.

(2) This act shall only take effect if House Bill 09-1289 is enacted and becomes law, and this act shall take effect either upon the applicable effective date of this act or upon the applicable effective date of House Bill 09-1289, whichever is later.".
