After consideration on the merits, the Committee recommends the following:

SB10-203 be amended as follows:

- 1 Amend reengrossed bill, page 5, strike lines 17 through 24.
- 2 Renumber succeeding sections accordingly.
- 3 Page 6, line 16, after "(7.3)", insert "(a)."
- 4 Page 6, line 17, strike "(a)" and substitute "(I)".
- 5 Page 6, line 20, strike "(b)" and substitute "(II)".
- 6 Page 6, line 23, strike "(c)" and substitute "(III)".
- 7 Page 6, line 26, strike "(d)" and substitute "(IV)".
- 8 Page 6, after line 27, insert:
 - 9 "(b) "DONATION" SHALL NOT INCLUDE A TRANSFER BY A
 - 10 MEMBERSHIP ORGANIZATION OF A PORTION OF A MEMBER'S DUES FOR AN
 - 11 INDEPENDENT EXPENDITURE SPONSORED BY SUCH MEMBERSHIP
 - 12 ORGANIZATION."
- 13 Page 7, line 4, strike "EXPENDITURES." and substitute "EXPENDITURES IN
- 14 EXCESS OF ONE THOUSAND DOLLARS."
- 15 Page 7, strike lines 22 through 24 and substitute:

1 "MORE PERSONS THAT MAKE AN INDEPENDENT EXPENDITURE IN EXCESS OF
2 ONE THOUSAND DOLLARS OR THAT COLLECTS IN EXCESS OF ONE
3 THOUSAND DOLLARS FROM ONE OR MORE PERSONS FOR".

4 Page 8, strike lines 3 and 4 and substitute:

5 "RADIO; AND BROADCAST, CABLE, OR SATELLITE TELEVISION.

6 (12.7) "OBLIGATING" MEANS, IN CONNECTION WITH A NAMED
7 CANDIDATE, AGREEING TO SPEND IN EXCESS OF ONE THOUSAND DOLLARS
8 FOR AN INDEPENDENT EXPENDITURE OR TO GIVE, PLEDGE, LOAN, OR
9 PURCHASE ONE OR MORE GOODS, SERVICES, OR OTHER THINGS OF VALUE
10 THAT HAVE A FAIR MARKET VALUE IN EXCESS OF ONE THOUSAND DOLLARS
11 AS AN INDEPENDENT EXPENDITURE. "OBLIGATING" SHALL NOT REQUIRE
12 THAT THE TOTAL AMOUNT OF ONE THOUSAND DOLLARS BE FINALLY
13 DETERMINED AT THE TIME OF THE AGREEMENT TO SPEND MONEYS FOR AN
14 INDEPENDENT EXPENDITURE OR TO GIVE, PLEDGE, LOAN, OR PURCHASE
15 ANYTHING OF VALUE."

16 Page 8, strike lines 12 through 14 and substitute:

17 "(5) OF ARTICLE XXVIII OF THE STATE CONSTITUTION."

18 Page 9, line 26, after "EXPENDITURE" insert "IN EXCESS OF ONE THOUSAND
19 DOLLARS".

20 Page 9, line 27, after "EXPENDITURE" insert "IN EXCESS OF ONE THOUSAND
21 DOLLARS".

22 Page 10, strike lines 11 through 17 and substitute:

23 "PRINCIPAL PLACE OF OPERATIONS; AND".

24 Renumber succeeding subparagraph accordingly.

25 Page 11, strike lines 16 through 20.

26 Renumber succeeding subsections accordingly.

27 Page 11, line 24, strike "IN THE AGGREGATE AMOUNT" and substitute "IN
28 EXCESS".

- 2 Page 12, line 15, strike "OR THAT" and substitute "THAT, FOR THE PURPOSE
- 3 OF MAKING AN INDEPENDENT EXPENDITURE".

- 5 Page 13, line 10, strike "(5)" and substitute "(4)".
- 6 Page 13, line 11, strike "SECTION 1-45-108 (2);" and substitute "SECTION
- 7 1-45-108 (2) FOR POLITICAL COMMITTEES;".
- 8 Page 13, line 12, after "EXPENDITURE" insert "IN EXCESS OF ONE
- 9 THOUSAND DOLLARS".
- 10 Page 13, line 21, after "EXPENDS" insert "IN EXCESS OF ONE THOUSAND
- 11 DOLLARS" and strike "OR MORE".
- 12 Page 14, line 2, strike "(6) and substitute "(5)".
- 13 Page 14, line 9, after "EXPENDS" insert "IN EXCESS OF ONE THOUSAND
- 14 DOLLARS" and strike "MONEYS".
- 15 Page 14, line 10, strike "IN AN AGGREGATE AMOUNT OF ONE THOUSAND
- 16 DOLLARS OR".
- 17 Page 14, line 11, strike "MORE".
- 18 Page 16, line 16, strike "(7)" and substitute "(6)".
- 19 Page 14, line 21, strike "AN AMOUNT" and substitute "EXCESS".
- 20 Page 14, line 22, strike "OR MORE".
- 21 Page 14, line 26, after "ANY" insert "SUCH".
- 22 Page 14, line 27, strike the third "THE" and substitute "SUCH".
- 23 Page 15, line 3, strike "(8)" and substitute "(7)".
- 24 Page 15, line 5, strike "PERSON'S" and substitute "IDENTITY OF THE

- 2 Page 15, line 10, strike "EXPENDITURE," and substitute "EXPENDITURE IN

5 POLITICAL COMMITTEES,".
- 6 Page 15, line 20, strike "SECTION 1-45-108 (2);" and substitute "SECTION
7 1-45-108 (2) FOR POLITICAL COMMITTEES;".
- 8 Page 15, line 25, strike "(10)" and substitute "(9)".
- 9 Page 16, line 2, strike "(10)" and substitute "(9)".
- 10 Page 16, line 10, strike "(10)" and substitute "(9)".
- 11 Page 16, line 12, after "EXPENDITURE" insert "IN EXCESS OF ONE
12 THOUSAND DOLLARS".
- 13 Page 16, strike lines 15 through 23 and substitute:
- 14 "(12) ON REPORTS IT FILES WITH THE APPROPRIATE OFFICIAL, AN
15 INDEPENDENT EXPENDITURE COMMITTEE THAT OBLIGATES IN EXCESS OF
16 ON THOUSAND DOLLARS FOR AN INDEPENDENT EXPENDITURE SHALL
17 DISCLOSE A GOOD FAITH ESTIMATE OF THE FAIR MARKET VALUE OF THE
18 EXPENDITURE IF THE COMMITTEE DOES NOT KNOW THAT ACTUAL AMOUNT
19 OF THE EXPENDITURE AS OF THE DATE THAT A REPORT IS REQUIRED TO BE
20 FILED WITH THE APPROPRIATE OFFICIAL."
- 21 Page 18, line 7, after the second "OF" insert "UP TO".
- 22 Page 18, line 22, strike "CONTRIBUTIONS, DONATIONS," and substitute
23 "DONATIONS".
- 24 Page 19, line 3, after "FINED" insert "UP TO".
