After consideration on the merits, the Committee recommends the following:

HB10-1186 be amended as follows:

- 1 Amend the Business Affairs and Labor Committee Report, dated
- 2 February 10, 2010, page 1, line 1, strike "page 5," and substitute:
- 3 "page 3, strike lines 17 and 18 and substitute:
- 4 (1) "CONVENIENCE STORE" MEANS A RETAIL BUSINESS WITH
- 5 LICENSED PREMISES OF LESS THAN FIVE THOUSAND SQUARE FEET, THAT IS
- 6 NOT SITUATED WITHIN A LARGER RETAIL ESTABLISHMENT, AND".
- 7 Page 5 of the printed bill,".
- 8 Page 1 of the report, strike lines 3 and 4 and substitute:
- 9 "CHRISTMAS DAY, UPON THE PAYMENT OF AN ANNUAL LICENSE FEE OF ONE
- 10 HUNDRED DOLLARS TO THE STATE LICENSING AUTHORITY.".
- 11 Page 5 of the bill, strike lines 14 through 27 and substitute:".
- 12 Page 1 of the report, line 5, strike ""(IV)" and substitute ""(II)".
- 13 Page 1 of the report, line 9, strike "STORE."." and substitute "STORE.
- 14 (III) UPON APPLICATION FOR RENEWAL OR TRANSFER OF ANY
- 15 LICENSE ISSUED UNDER THIS PARAGRAPH (e), THE APPLICANT SHALL
- 16 REPORT TO THE LIQUOR ENFORCEMENT DIVISION OR ITS DESIGNEE THE
- 17 APPLICANT'S TOTAL SALES, BY VOLUME, OF MALT LIQUORS AT EACH OF ITS

1 LICENSED PREMISES DURING THE IMMEDIATELY PRECEDING TWELVE
2 MONTHS."

3 Page 6 of the bill, line 18, strike "amended" and substitute "amended, and
4 the said 12-46-107 is further amended BY THE ADDITION OF A NEW
5 SUBSECTION,".

6 Page 7 of the bill, after line 6 insert:

7 "(3) (a) NOTWITHSTANDING SUBSECTION (2) OF THIS SECTION, FOR
8 MALT LIQUOR STORE LICENSES ISSUED UNDER SECTION 12-46-104 (1) (e),
9 THE FOLLOWING LICENSE FEES SHALL BE PAID TO THE TREASURER OF THE
10 MUNICIPALITY, CITY AND COUNTY, OR COUNTY WHERE THE LICENSED
11 PREMISES IS LOCATED ANNUALLY IN ADVANCE:

12 (I) FOR EACH MALT LIQUOR STORE LICENSE FOR PREMISES
13 LOCATED WITHIN THE MUNICIPAL LIMITS OF ANY MUNICIPALITY OR CITY
14 AND COUNTY, ONE HUNDRED FIFTY DOLLARS;

15 (II) FOR EACH MALT LIQUOR STORE LICENSE FOR PREMISES
16 LOCATED OUTSIDE THE MUNICIPAL LIMITS OF ANY MUNICIPALITY OR CITY
17 AND COUNTY, TWO HUNDRED FIFTY DOLLARS.

18 (b) EIGHTY-FIVE PERCENT OF THE LOCAL LICENSE FEES SET FORTH
19 IN PARAGRAPH (a) OF THIS SUBSECTION (3) SHALL BE PAID TO THE
20 DEPARTMENT OF REVENUE, WHICH SHALL TRANSMIT THE FEES TO THE
21 STATE TREASURER TO BE CREDITED TO THE OLD AGE PENSION FUND
22 CREATED IN SECTION 1 OF ARTICLE XXIV OF THE STATE CONSTITUTION."."
