Fiscal Assessment of Proposed Amendment SB114 L.018.

This memorandum is an assessment of the fiscal impact of the attached proposed amendment to **SB10-114**. This fiscal assessment is for the impact of the bill with inclusion of this amendment <u>only</u>. Any other added amendment could influence the fiscal impact.

Summary of Proposed Amendment

Amendment L.018 removes the section of the reengrossed bill concerning Community Centered Boards (CCBs). Specifically, it eliminates the requirement that certain records generated by the CCBs be made available to the public and maintained by the Department of Human Services (DHS). It also removes the requirement that the DHS post CCB contracts on its website.

Fiscal Impact of Amendment

Amendment L.018 eliminates the DHS of \$350,000 in FY 2010-11 and \$300,000 in FY 2011-12 identified in the fiscal note dated March 23rd. These costs are split between the General Fund and federal funds. The fiscal note estimated that the DHS will have to maintain more than 1.9 million CCB records per year under the bill and obtain contract services to build a data management system to receive and maintain these records. The amendment eliminates this requirement and the associated costs. In addition, the amendment reduces administrative costs at the CCBs for responding to open records requests.

The amended bill, including L.018, will increase state expenditures by \$410,650 and 8.1 FTE in FY 2010-11 and \$372,822 and 8.1 FTE in FY 2011-12. As described in the fiscal note, these remaining costs are for departments to review and post contracts and other purchasing documents on their websites.
