Page 9, after line 10 insert: "(VI) MAY REQUIRE THE PERSON TO SUBMIT TO CONTINUOUS ALCOHOL MONITORING USING SUCH TECHNOLOGY OR DEVICES AS ARE AVAILABLE TO THE COURT FOR SUCH PURPOSE; AND (VII) MAY IMPOSE SUCH ADDITIONAL CONDITIONS OF PROBATION AS MAY BE PERMITTED BY LAW.".
