AN 7 EMPLOYEE OF A RETAIL LIQUOR STORE OR LIQUOR-LICENSED DRUGSTORE 8 WHO IS LESS THAN TWENTY-ONE YEARS OF AGE SHALL NOT SELL, DELIVER, 9 OR CARRY MALT, VINOUS, OR SPIRITUOUS LIQUORS TO A CUSTOMER'S 10 VEHICLE, AND SHALL NOT CHECK PROOF OF AGE OF A CUSTOMER 11 ATTEMPTING TO PURCHASE MALT, VINOUS, OR SPIRITUOUS LIQUORS.".
