HB10-1076 be amended as follows:

- 1 Amend printed bill, page 2, strike lines 2 through 16.
- 2 Renumber succeeding sections accordingly.
- 3 Page 2, line 20, strike everything after the comma.
- 4 Page 2, strike line 21 and substitute ""EMPLOYEE" INCLUDES A PERSON
- 5 WHO".
- 6 Page 3, line 4, strike everything after the comma.
- 7 Page 3, strike line 5 and substitue ""EMPLOYEE" INCLUDES A PERSON".
- 8 Page 3, after line 7, insert:
 - 9 "SECTION 3. Part 2 of article 41 of title 8, Colorado Revised
 - 10 Statutes, is amended BY THE ADDITION OF A NEW SECTION to
 - 11 read:
 - 12 "8-41-210. Coverage for property tax work-off program
 - 13 participants. NOTWITHSTANDING ANY PROVISION OF LAW TO THE
 - 14 CONTRARY, A GOVERNMENTAL ENTITY OR PRIVATE NONPROFIT OR
 - 15 FOR-PROFIT ENTITY THAT HAS A CONTRACT WITH A GOVERNMENTAL
 - 16 ENTITY THAT IS SELF-INSURED UNDER ARTICLES 40 TO 47 OF THIS TITLE
 - 17 MAY PURCHASE WORKERS' COMPENSATION INSURANCE FROM ANY INSURER
 - 18 AUTHORIZED TO TRANSACT THE BUSINESS OF WORKERS' COMPENSATION

1 INSURANCE IN THIS STATE FOR THE EXPRESS PURPOSE
2 OF COVERING PARTICIPANTS IN THE PROPERTY TAX WORK-OFF PROGRAM
3 ESTABLISHED PURSUANT TO ARTICLE 3.7 OF TITLE 39, C.R.S. THE COST OF
4 A WORKERS' COMPENSATION INSURANCE POLICY THAT COVERS WORK-OFF
5 PROGRAM PARTICIPANTS MAY BE PRORATED TO THE PARTICIPANTS AND
6 INCLUDED IN THE PARTICIPANTS' WORK-OFF."

7 Renumber succeeding sections accordingly.

8 Page 3, line 11, strike everything after "**participants**".

9 Page 3, line 12, strike "C.R.S., "EMPLOYMENT" MAY INCLUDE" and
10 substitute ""EMPLOYMENT" INCLUDES".

11 Page 1, line 102, after "OF" insert "EMPLOYEE".
