After consideration on the merits, the Committee recommends the following:

HB10-1354 be amended as follows:

1 Amend printed bill, page 13, after line 23 insert:

2 "SECTION 12. 31-31-202, Colorado Revised Statutes, is
3 amended BY THE ADDITION OF A NEW SUBSECTION to read:

4 **31-31-202. Powers and duties of the board.** (7) (a) ON OR
5 BEFORE JANUARY 20, 2011, AND ON OR BEFORE JANUARY 20 EACH YEAR
6 THEREAFTER, THE BOARD SHALL SUBMIT TO THE FINANCE COMMITTEES OF
7 THE HOUSE OF REPRESENTATIVES AND THE SENATE, OR ANY SUCCESSOR
8 COMMITTEES, A REPORT CONCERNING IMPLEMENTATION OF THE
9 PROVISIONS OF THIS ARTICLE AND ARTICLE 30.5 OF THIS TITLE FOR THE
10 PRECEDING FISCAL YEAR AND ANY RECOMMENDATIONS FOR LEGISLATION
11 PERTAINING TO THIS ARTICLE AND ARTICLE 30.5 OF THIS TITLE.

12 (b) THE CHAIR PERSONS OF THE FINANCE COMMITTEES OF THE
13 HOUSE OF REPRESENTATIVES AND THE SENATE, OR ANY SUCCESSOR
14 COMMITTEES, OR DESIGNEES OF THE CHAIR PERSONS, MAY ANNUALLY
15 INTRODUCE NO MORE THAN FOUR BILLS BASED ON THE
16 RECOMMENDATIONS MADE IN THE ANNUAL REPORT. ANY BILLS
17 INTRODUCED PURSUANT TO THIS PARAGRAPH (b) SHALL NOT BE SUBJECT
18 TO ANY LIMITATIONS IMPOSED BY LEGISLATIVE RULE ON THE NUMBER OF
19 BILLS THAT A LEGISLATOR MAY INTRODUCE. ANY BILLS INTRODUCED
20 PURSUANT TO THIS PARAGRAPH (b) SHALL BE SUBJECT TO THE FINAL
21 INTRODUCTION DEADLINE FOR BILLS IN THE HOUSE OF INTRODUCTION
22 UNLESS THE INTRODUCTION DEADLINE IS WAIVED AS PROVIDED IN THE
23 JOINT RULES OF THE HOUSE OF REPRESENTATIVES AND THE SENATE."
