Description: Meets monthly.

The State Board of Stock Inspection Commissioners is composed of 5 commissioners appointed by the Governor with the consent of the Senate, all of whom shall be actively engaged in the production or feeding of cattle, horses, or sheep.

- 2 of the members shall represent the nonconfinement cattle industry;
- 2 of the members shall represent the confinement cattle industry; and
- 1 shall have broad general knowledge of the Colorado livestock industry and shall represent the commodity, other than the confinement and nonconfinement cattle industries, with the largest percentage of charged fees.

The members of the board shall be appointed in such manner as will at all times represent as nearly as possible all sections of the state wherein livestock is a major activity, but at no time shall any two members be residents of the same particular section of the state. The term of office of said commissioners shall be for a period of four years.

The board makes rules and regulations regarding brand inspection and livestock laws in accordance with law, and regulates fees consistent with the law on brand inspection fees. The board also sets service charges, procedures and administers the Estray Fund, licenses public livestock markets, secures bond and surety on butchers and slaughterers.


Pursuant to the powers conferred upon me by the Constitution and Laws of the State of Colorado, I have the honor to designate, appoint, and submit to your consideration, the following:
