**Description:**

The Colorado Wildlife Habitat Stamp Committee consists of 11 members appointed by the Governor and **confirmed by the Senate** as follows:

- \* 4 sportspersons who represent the four quadrants of the state;
- \* 2 representatives of national or regionally recognized conservation organizations whose missions are focused on nongame wildlife and whose membership is composed primarily of nongame wildlife users;
- \* 2 landowners actively engaged in agriculture;
- \* 1 citizen at large; and
- \* 2 Division of Wildlife representatives as ex officio members, at least one of whom shall be a wildlife biologist.

Staggered appointments shall be made so that not more than two members' terms expire in any one year, and thereafter appointments shall be for terms of four years each. Members shall be limited to two consecutive four-year terms. The committee is repealed December 31, 2010, but prior to its repeal, the committee shall receive a sunset review as provided for in section 2-3-1203.

for terms expiring December 31, 2012:


Daniel J. Larkin of Salida, Colorado, a sportsperson, reappointed;
