 - i. A flashing yellow light shall be mounted to the front of the vehicle.
 - ii. The permittee shall attach at least one but not more than three yellow or red cluster lights to the overhang, as follows:

Permit Addendum

An extra-legal vehicle or load may travel on state highways twenty-four hours per day, seven days per week, EXCEPT as follows:

- 1. An extra-legal vehicle or load greater than 14 feet wide is prohibited from travel during the hours of darkness.
- 2. An extra-legal vehicle or load less than 14 feet wide travelling at night shall comply with the following requirement:
 - a. All lighting required by §§ 42-4-203 through 42-4-234, C.R.S., and the Commercial Vehicle Rules, as applicable.
 - b. If the extra-legal vehicle or load is not more than twelve feet in width:
 - i. A flashing yellow light shall be mounted on the front of the vehicle.
 - ii. At least two but not more than three flashing yellow lights shall be mounted to the extreme rear.
 - c. If the extra-legal vehicle or load is more than twelve feet in width but not more than fourteen feet in width:
 - i. On all two-lane highways, one pilot car escort vehicle shall be in the front.
 - ii. On all four-lane highways, one pilot car escort vehicle shall be in the rear.

d.if an extra-legal or load exceeds the legal limits for length or has an overhang:

- i. A flashing yellow light shall be mounted to the front of the vehicle.
- ii. The permittee shall attach at least one but not more than three yellow or red cluster lights to the overhang, as follows:

If the overhang is in the rear, red cluster lights shall be used.

If the overhang is in the front, yellow cluster lights shall be used.

3.Holiday Restrictions: Travel is prohibited from 6:00 a.m. until 9:00 p.m. on Memorial Day, Independence Day, and Labor Day.

When Independence Day falls on a Saturday travel is prohibited on the previous Friday from 12:00 noon until 9:00 p.m.
