**A BILL FOR AN ACT**

101     **CONCERNING THE FUNDING OF COLORADO WATER CONSERVATION**  
102             **BOARD PROJECTS, AND MAKING APPROPRIATIONS IN**  
103             **CONNECTION THEREWITH.**

**Bill Summary**

The bill appropriates the following amounts from the Colorado water conservation board construction fund for the following projects:

!       \$250,000 for continuation of satellite monitoring system maintenance;

- ! \$50,000 for instream flow engineering and technical support services;
- ! \$175,000 for continuation of the weather modification program;
- ! \$500,000 for continuation of the Colorado floodplain map modernization program;
- ! \$250,000 for continuation of the watershed restoration program; and
- ! Up to \$300,000 to restore the unencumbered balance in the flood response fund to \$300,000.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1. Continuation of the satellite monitoring system**  
3 **maintenance - appropriation.** (1) In addition to any other  
4 appropriation, there is hereby appropriated, out of any moneys in the  
5 Colorado water conservation board construction fund not otherwise  
6 appropriated, to the department of natural resources, for allocation to the  
7 division of water resources, for the fiscal year beginning July 1, 2010, the  
8 sum of two hundred fifty thousand dollars (\$250,000), or so much thereof  
9 as may be necessary, for renovation of existing gauging stations,  
10 replacement of outdated collection platforms, and upgrading of  
11 transmission components of the satellite monitoring system established  
12 and operated pursuant to section 37-80-102 (10), Colorado Revised  
13 Statutes, stream gauge flood hardening projects, and data collection  
14 efforts related to flood forecasting and warning.

15           (2) The moneys appropriated in subsection (1) of this section shall  
16 remain available for the designated purposes until they are fully  
17 expended.

18           **SECTION 2. Instream flow engineering and technical support**  
19 **services - appropriation.** (1) In addition to any other appropriation,  
20 there is hereby appropriated, out of any moneys in the Colorado water

1 conservation board construction fund not otherwise appropriated, to the  
2 department of natural resources, for allocation to the Colorado water  
3 conservation board, for the fiscal year beginning July 1, 2010, the sum of  
4 fifty thousand dollars (\$50,000), or so much thereof as may be necessary,  
5 for engineering and technical support services related to the board's  
6 instream flow and natural lake level program.

7 (2) The moneys appropriated in subsection (1) of this section shall  
8 remain available for the designated purposes until they are fully  
9 expended.

10 **SECTION 3. Continuation of the weather modification**  
11 **program - appropriation.** (1) In addition to any other appropriation,  
12 there is hereby appropriated, out of any moneys in the Colorado water  
13 conservation board construction fund not otherwise appropriated, to the  
14 department of natural resources, for allocation to the Colorado water  
15 conservation board, for the fiscal year beginning July 1, 2010, the sum of  
16 one hundred seventy-five thousand dollars (\$175,000), or so much thereof  
17 as may be necessary, for the board to continue to assist water  
18 conservation districts, water conservancy districts, and other water  
19 providers with the development of cloud seeding programs that provide  
20 benefits to recreation, streams, and reservoirs through snowpack  
21 enhancement.

22 (2) The moneys appropriated in subsection (1) of this section shall  
23 remain available for the designated purposes until they are fully  
24 expended.

25 **SECTION 4. Continuation of the Colorado floodplain map**  
26 **modernization program - appropriation.** (1) In addition to any other  
27 appropriation, there is hereby appropriated, out of any moneys in the

1 Colorado water conservation board construction fund not otherwise  
2 appropriated, to the department of natural resources, for allocation to the  
3 Colorado water conservation board, for the fiscal year beginning July 1,  
4 2010, the sum of five hundred thousand dollars (\$500,000), or so much  
5 thereof as may be necessary, to restore the unencumbered balance in the  
6 previously appropriated map modernization account of the board to five  
7 hundred thousand dollars (\$500,000), for the board to continue to assist  
8 with the preparation of revised and improved floodplain studies and maps  
9 for communities throughout Colorado and participate in federally  
10 sponsored floodplain map modernization activities.

11 (2) The moneys appropriated in subsection (1) of this section shall  
12 remain available for the designated purposes until the project is  
13 completed.

14 **SECTION 5. Continuation of the watershed restoration**  
15 **program - appropriation.** (1) In addition to any other appropriation,  
16 there is hereby appropriated, out of any moneys in the Colorado water  
17 conservation board construction fund not otherwise appropriated, to the  
18 department of natural resources, for allocation to the Colorado water  
19 conservation board, for the fiscal year beginning July 1, 2010, the sum of  
20 two hundred fifty thousand dollars (\$250,000), or so much thereof as may  
21 be necessary, for the board to continue to provide planning and  
22 engineering studies, including implementation measures, to address  
23 technical needs for watershed restoration and flood mitigation projects  
24 throughout the state.

25 (2) The moneys appropriated in subsection (1) of this section shall  
26 remain available for the designated purposes until they are fully  
27 expended.

1           **SECTION 6. Restoration of flood response fund balance.** The  
2 state treasurer shall transfer a total of three hundred thousand dollars  
3 (\$300,000), or so much thereof as may be necessary, from the unreserved  
4 cash in the Colorado water conservation board construction fund to the  
5 flood response fund created in section 37-60-123.2, Colorado Revised  
6 Statutes, in order to restore the unencumbered balance in the flood  
7 response fund to three hundred thousand dollars (\$300,000).

8           **SECTION 7. 39-29-109 (2) (a), Colorado Revised Statutes, is**  
9 amended BY THE ADDITION OF A NEW SUBPARAGRAPH to read:

10           **39-29-109. Severance tax trust fund - created - administration**  
11 **- distribution of moneys - repeal.** (2) State severance tax receipts shall  
12 be credited to the severance tax trust fund as provided in section  
13 39-29-108. Except as otherwise set forth in section 39-29-109.5, all  
14 income derived from the deposit and investment of the moneys in the  
15 fund shall be credited to the fund. At the end of any fiscal year, all  
16 unexpended and unencumbered moneys in the fund shall remain therein  
17 and shall not be credited or transferred to the general fund or any other  
18 fund. All moneys in the fund shall be subject to appropriation by the  
19 general assembly for the following purposes:

20           (a) **The perpetual base account.** (VI) (A) NOTWITHSTANDING  
21 ANY PROVISION OF THIS PARAGRAPH (a) TO THE CONTRARY, THE STATE  
22 TREASURER SHALL TRANSFER TO THE COLORADO WATER CONSERVATION  
23 BOARD, ALSO REFERRED TO IN THIS SUBPARAGRAPH (VI) AS THE "BOARD",  
24 THIRTY-SIX MILLION DOLLARS FOR THE PURCHASE OF ALL OR A PORTION  
25 OF COLORADO'S ALLOTMENT OF ANIMAS-LA PLATA PROJECT WATER. THE  
26 STATE TREASURER SHALL MAKE THE TRANSFER MANDATED BY THIS  
27 SUB-SUBPARAGRAPH (A) IN THREE CONSECUTIVE ANNUAL INSTALLMENTS

1 OF TWELVE MILLION DOLLARS ON JUNE 30 OF EACH YEAR, COMMENCING  
2 JUNE 30, 2011.

3 (B) NOTWITHSTANDING ANY OTHER LAW, INCLUDING SECTION  
4 24-30-1303, C.R.S., ONCE SUFFICIENT FUNDS HAVE BEEN APPROPRIATED  
5 TO THE BOARD FOR SUCH PURPOSES, THE DEPARTMENT OF NATURAL  
6 RESOURCES, ACTING THROUGH THE BOARD, IS AUTHORIZED TO ENTER INTO  
7 A CONTRACT OR OTHER AGREEMENT WITH THE UNITED STATES BUREAU  
8 OF RECLAMATION TO ACQUIRE ALL OR A PORTION OF COLORADO'S  
9 ALLOCATION OF WATER IN THE ANIMAS-LA PLATA PROJECT. THE  
10 AUTHORITY TO ACQUIRE SUCH WATER INCLUDES THE ABILITY TO  
11 CONTRACT WITH AND ALLOCATE WATER TO LOCAL ENTITIES AND WATER  
12 PROVIDERS; TO RECEIVE AND EXPEND MONEYS FROM ENTITIES IN  
13 REPAYMENT; TO UNDERTAKE OPERATIONS, MAINTENANCE, AND  
14 REPLACEMENT COSTS; TO PAY THE COSTS OF STORAGE OR OTHER  
15 NECESSARY EXPENSES; AND TO OTHERWISE IMPLEMENT THE PURPOSES OF  
16 THIS SUB-SUBPARAGRAPH (B) AND UTILIZE THE WATER ACQUIRED. THE  
17 BOARD IS ALSO AUTHORIZED TO UNDERTAKE SUCH ACTION AS IS  
18 NECESSARY TO LEASE, SUBLEASE, EXCHANGE, SELL, ASSIGN, OR  
19 OTHERWISE EFFECTUATE THE USE OF PROJECT WATER ACQUIRED UNDER  
20 THIS SUBPARAGRAPH (VI). IN THE EVENT OF A CONFLICT BETWEEN THE  
21 APPLICATION OF STATE OR FEDERAL LAW OR RULES, INCLUDING CHAPTER  
22 3 OF THE STATE FISCAL RULES IN EXISTENCE AS OF THE EFFECTIVE DATE OF  
23 THIS SUBPARAGRAPH (VI), FEDERAL LAWS AND RULES SHALL APPLY.

24 (C) EXCEPT AS PROVIDED IN SUB-SUBPARAGRAPH (D) OF THIS  
25 SUBPARAGRAPH (VI), THE MONEYS TRANSFERRED TO THE BOARD  
26 PURSUANT TO SUB-SUBPARAGRAPH (A) OF THIS SUBPARAGRAPH (VI)  
27 SHALL REMAIN AVAILABLE TO THE BOARD UNTIL EXPENDED.

1           (D) IF, ON JUNE 30, 2015, ANY MONEYS APPROPRIATED UNDER  
2           SUB-SUBPARAGRAPH (A) OF THIS SUBPARAGRAPH (VI) HAVE NOT BEEN  
3           FULLY EXPENDED, THE UNEXPENDED MONEYS ARE DEAUTHORIZED AND  
4           SHALL REVERT TO THE PERPETUAL BASE ACCOUNT.

5           (E) THIS SUBPARAGRAPH (VI) IS REPEALED, EFFECTIVE JULY 1,  
6           2015.

7           **SECTION 8. Safety clause.** The general assembly hereby finds,  
8           determines, and declares that this act is necessary for the immediate  
9           preservation of the public peace, health, and safety.
