The Friday, March 19 deadline (the 66th legislative day) for final passage, including any conference committee report, for any bill prescribing all or a substantial portion of the total 41 funding for public schools pursuant to the "Public School Finance Act of 1994", article 54 of title 22, Colorado Revised Statutes, as previously extended until Monday, April 5, 2010 (the 83rd legislative day) is further extended until Tuesday, April 13, 2010 (the 91st legislative day).
