SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor and Technology.

HB11-1188 be amended as follows:

1 Amend reengrossed bill, page 4, strike lines 13 through 22 and substitute:

2 "(x) TO REQUIRE, COERCE, OR ATTEMPT TO COERCE A MOTOR
3 VEHICLE DEALER TO SUBSTANTIALLY ALTER A FACILITY OR PREMISES IF:

4 (I) THE FACILITY OR PREMISES HAS BEEN ALTERED WITHIN THE
5 LAST TEN YEARS AT A COST OF MORE THAN TWO HUNDRED FIFTY
6 THOUSAND DOLLARS AND THE ALTERATION WAS REQUIRED OR APPROVED
7 BY THE MANUFACTURER, DISTRIBUTOR, OR MANUFACTURER
8 REPRESENTATIVE UNLESS THE MOTOR VEHICLE DEALER SELLS ONLY
9 MOTORCYCLES OR MOTORCYCLES AND POWERSPORTS VEHICLES; EXCEPT
10 THAT THIS PARAGRAPH (x) DOES NOT APPLY TO IMPROVEMENTS MADE TO
11 COMPLY WITH HEALTH OR SAFETY LAWS OR TO ACCOMMODATE THE
12 TECHNOLOGY REQUIREMENTS NECESSARY TO SELL OR SERVICE A
13 LINE-MAKE; OR

14 (II) THE MOTOR VEHICLE DEALER SELLS ONLY MOTORCYCLES OR
15 MOTORCYCLES AND POWERSPORTS VEHICLES, THE FACILITY OR PREMISES
16 HAS BEEN ALTERED WITHIN THE LAST TEN YEARS AT A COST OF MORE
17 THAN TWENTY-FIVE THOUSAND DOLLARS, AND THE ALTERATION WAS
18 REQUIRED OR APPROVED BY THE MANUFACTURER, DISTRIBUTOR, OR
19 MANUFACTURER REPRESENTATIVE; EXCEPT THAT THIS PARAGRAPH (x)
20 DOES NOT APPLY TO IMPROVEMENTS MADE TO COMPLY WITH HEALTH OR
21 SAFETY LAWS OR TO ACCOMMODATE THE TECHNOLOGY REQUIREMENTS
22 NECESSARY TO SELL OR SERVICE A LINE-MAKE."

23 Page 6, strike line 26 and substitute "TEN YEARS AT A COST OF MORE THAN
24 TWENTY-FIVE THOUSAND".
