Net to State of Colorado

\$69,011.95 was transferred to the State of Colorado from the restricted account held by Colorado Preservation, Inc. at Colorado Business Bank in June, 2011 as required. The transfer of funds to the State consisted of the following:

A \$50,000 pledge was made to Colorado Preservation, Inc. by AngloGold/Ashanti N.A. on March 17, 2010 for the purposes of funding the marketing consulting retainer paid to Creative Strategies Group, the *Share in the Care Colorado* website and necessary campaign collateral. \$25,000 was paid to CPI in 2010. The second installment of \$25,000 was received in January 2011.

A minimum donation of \$10 is required and all on-line donations are securely process by Community First Foundation and transferred on a monthly basis into the restricted account at Colorado Business Bank. Community First Foundation does not charge an administrative fee for this service.

992 individual gifts have been received by the campaign (not including the numerous anonymous small donations made via the 3 donation boxes inside the capitol. The list of 539 individual campaign donors is attached. An additional 453 gifts have been contributed via the mobile texting program. A list of those donors, who can only be legally identified by their cell phone number, is also attached.

Corporate Campaign:

Legislation enacted in 2011 allowed for an expansion of the scope of the restoration project from approximately \$12 million to \$17 million. The goal of the campaign remains is to raise the majority of the 13 million goal from the corporate campaign as follows:

Governor Hickenlooper and Sen. Radio psa's are in the process of being scripted and scheduled with Entercom. A campaign to utilize the in-kind gift of outdoor advertising is being developed, as are a series of advertisements for print media outlets statewide.

Sponsor Approval Task Force

The campaign is waiting to learn if a replacement for Rep. Jim Riesberg, who is vacating his House seat to assume the chairmanship of the Colorado Insurance Commission, will be made. The remaining members of this task force are, CBAC chair Georgianna Contiguglia, and OSPB deputy director Erick Scheminke. The Sponsorship Task Force meets with campaign staff on an as needed basis and includes representation by Kori Donaldson (CDC) and Jennifer Thompson (CBAC).
