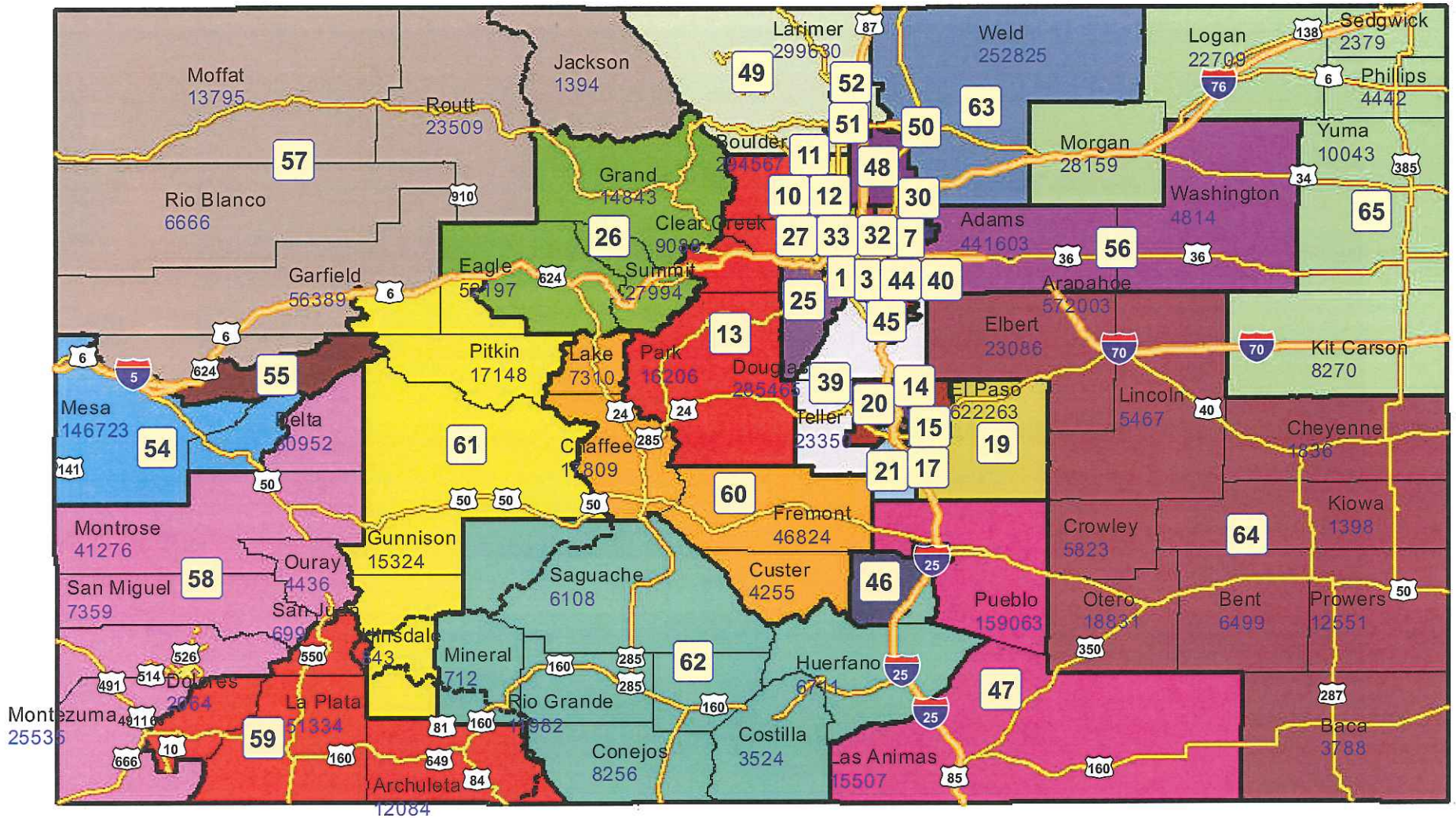

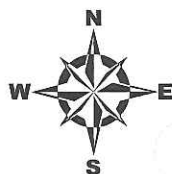
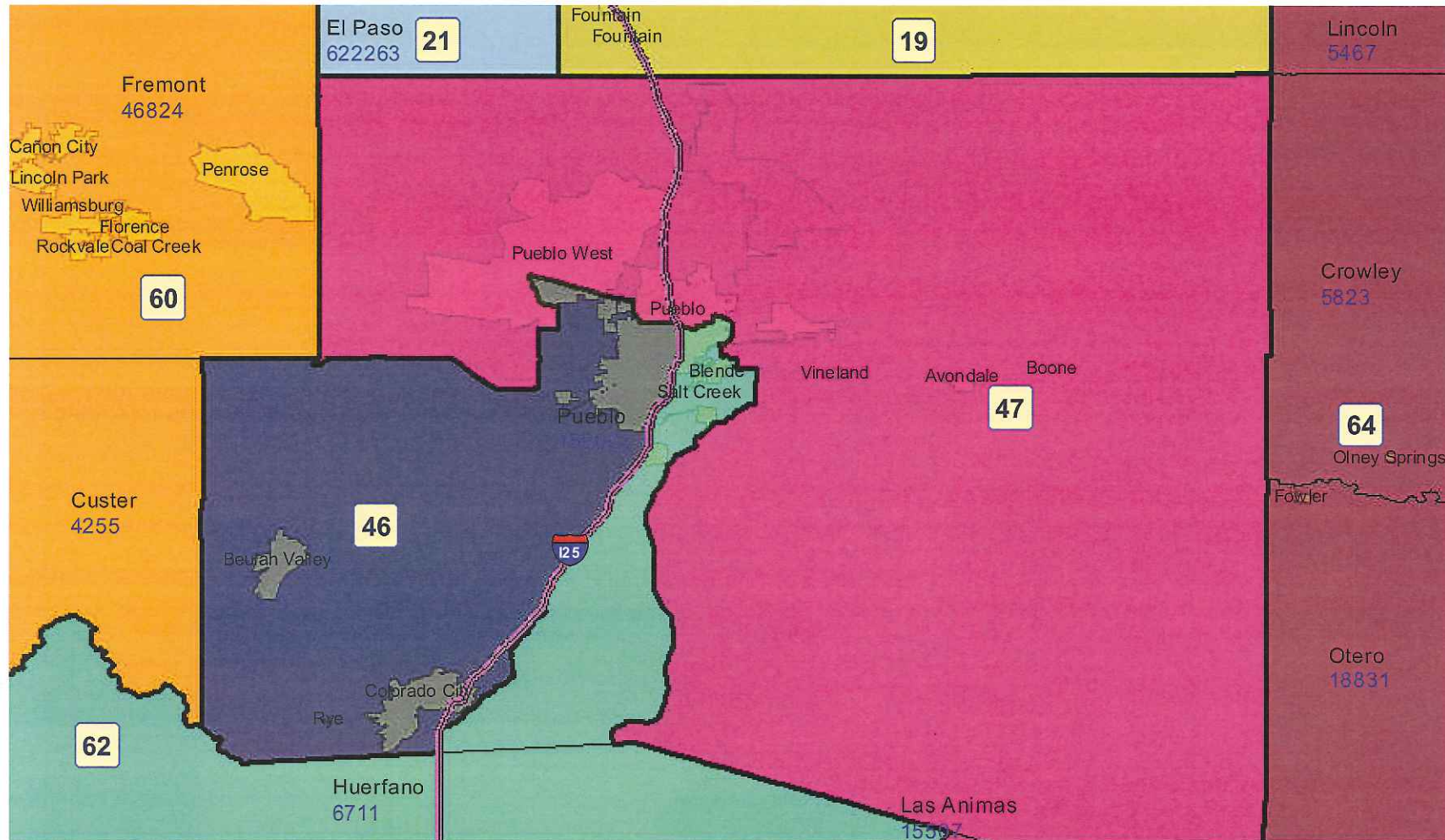

House Resubmitted Plan Av1 Pueblo County

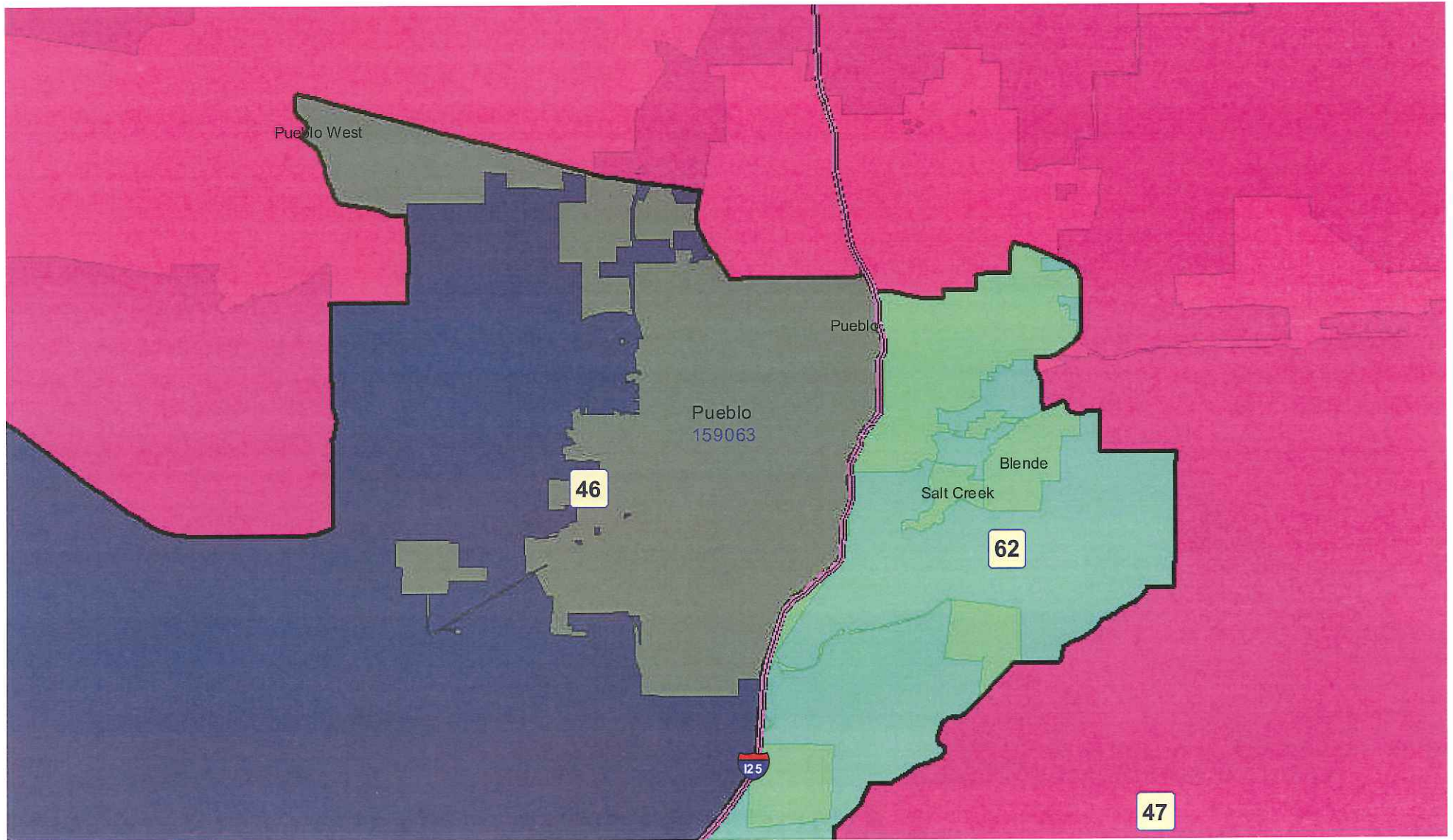

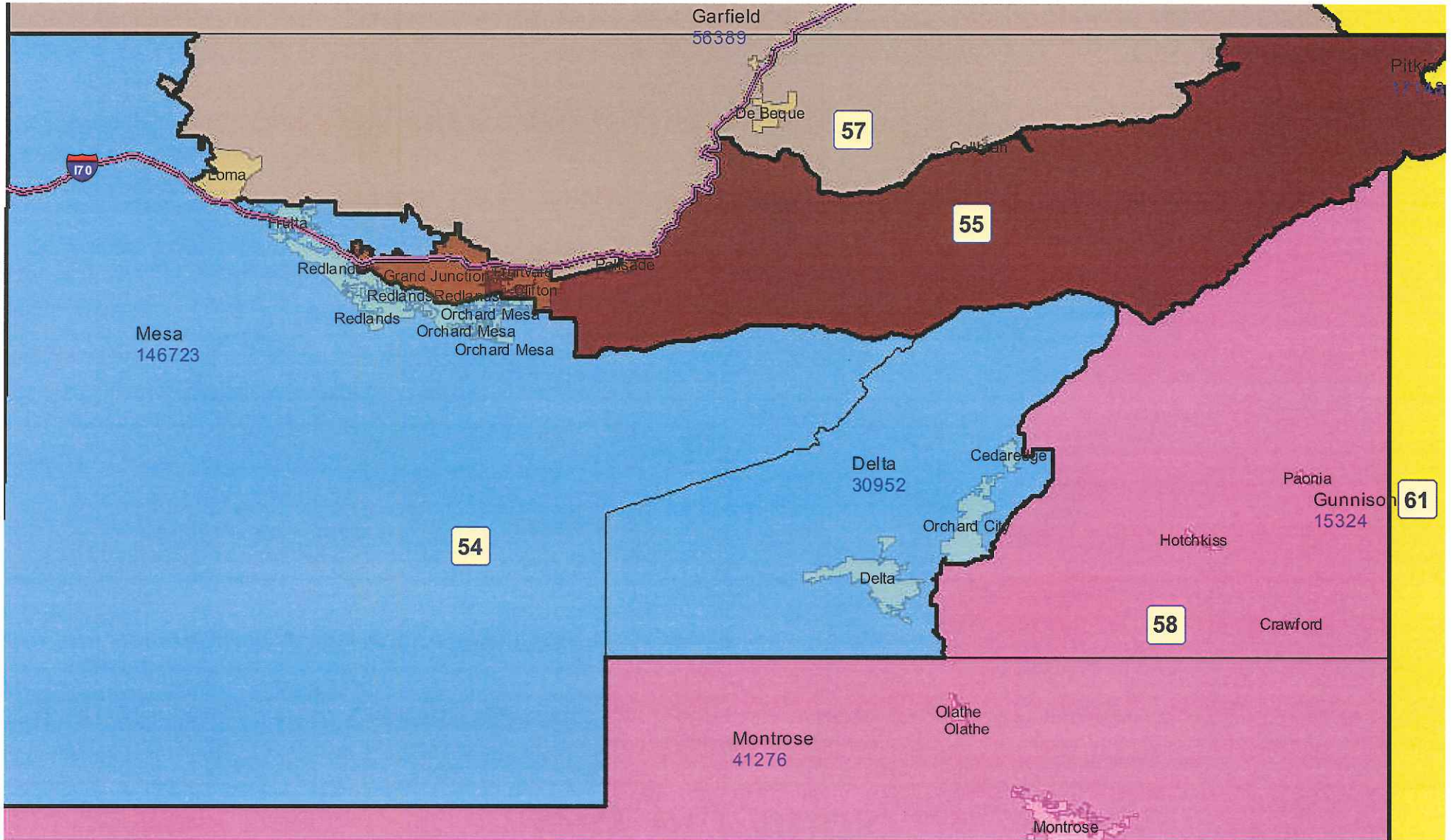

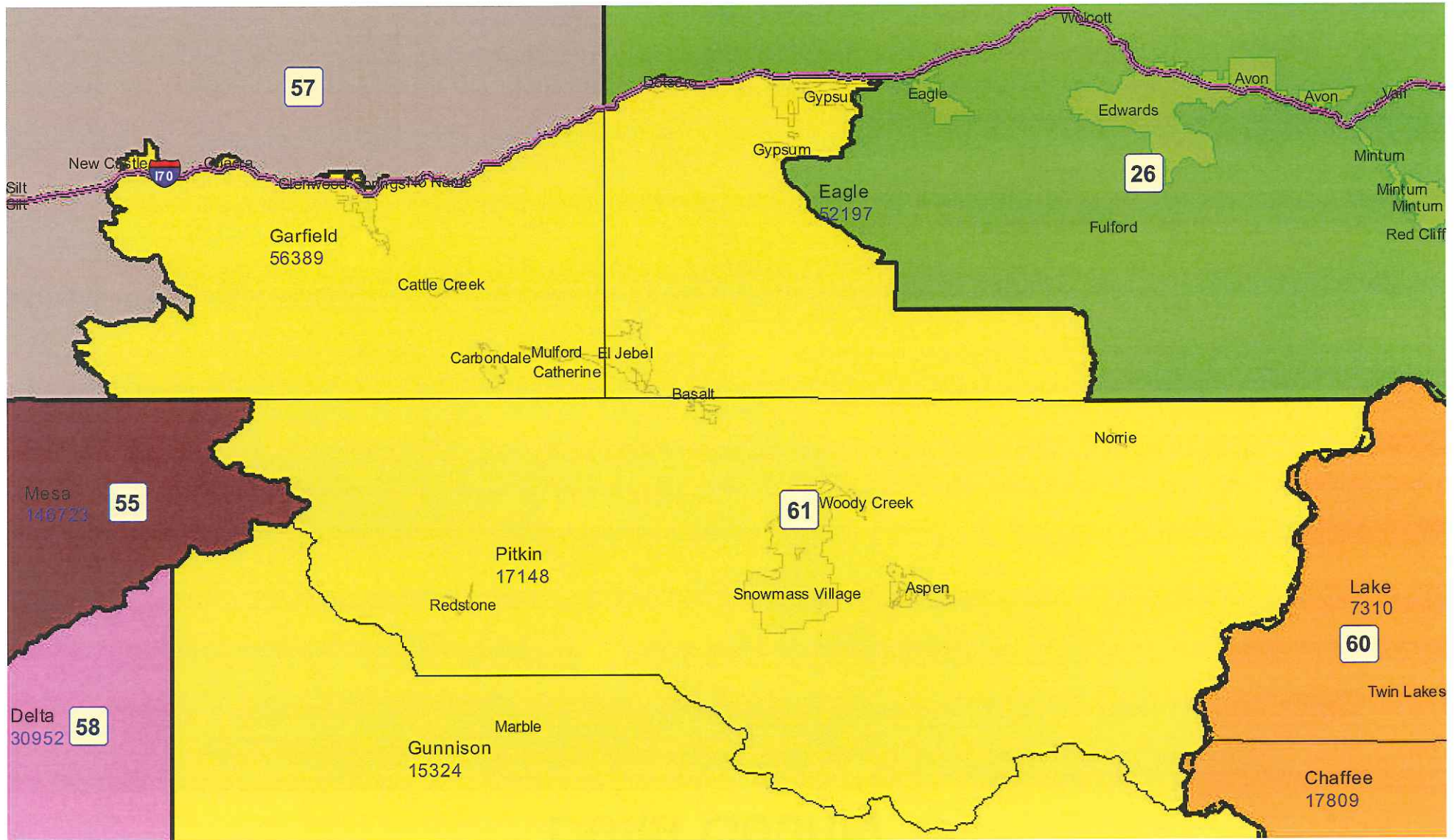

Roaring Fork Valley

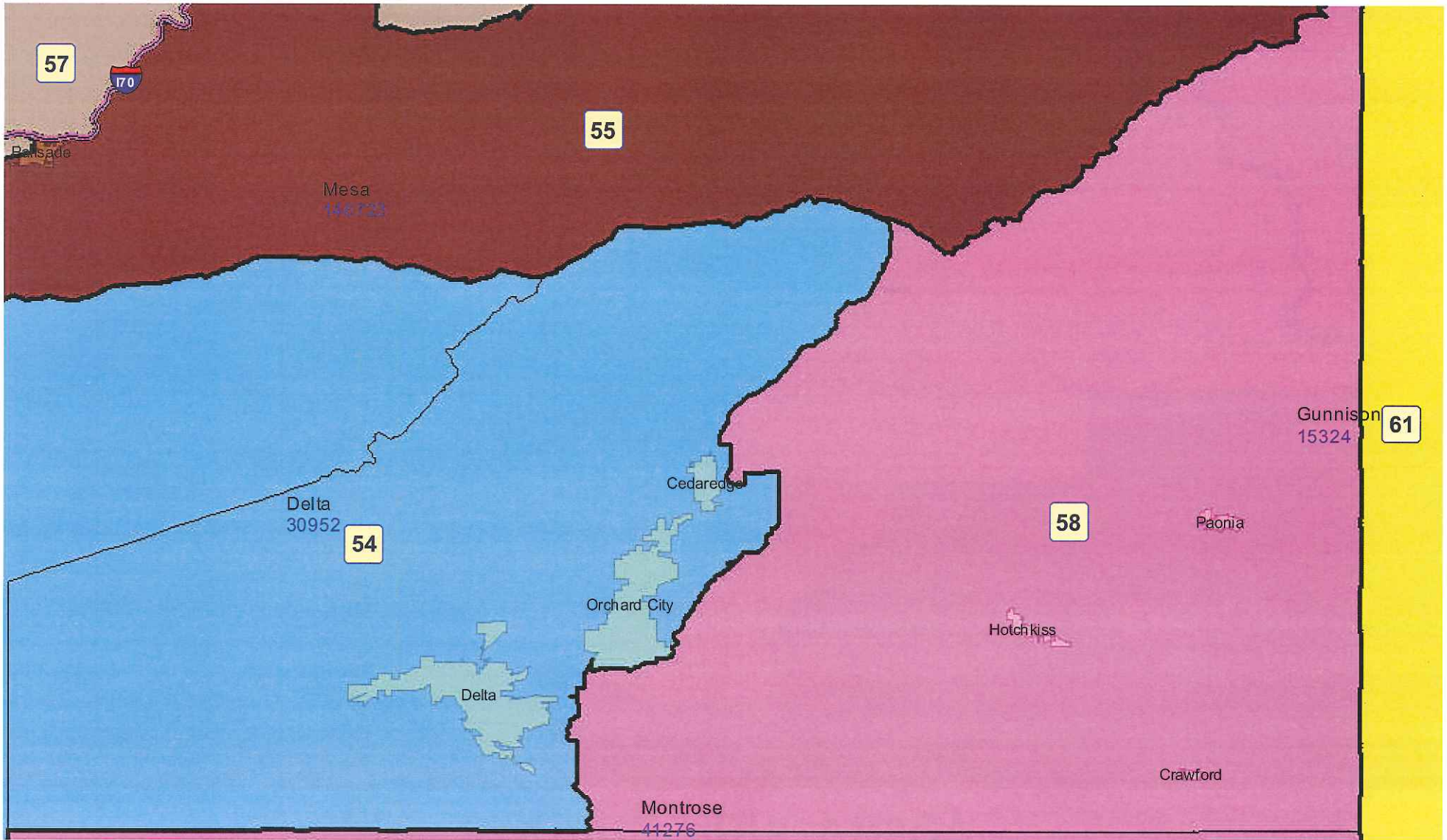
