- 7 "(m) IMPOSE FINES AGAINST CORPORATIONS IN ACCORDANCE WITH
- 8 SECTION 12-64-123 (2).".
  
- 9 Page 18, line 4, strike "on" and substitute "on IN".
  
- 10 Page 22, line 24, strike "BOARD." and substitute "BOARD BY RULE.".
  
- 11 Page 23, line 23, before "APPLICATION" insert "RECEIPT OF THE".
  
- 12 Page 23, line 24, strike "COMPETENCE DURING" and substitute
- 13 "COMPETENCE,".
  
- 14 Page 23, line 25, strike "THAT PERIOD,".

12 **"12-64-108. License by endorsement - rules.** THE BOARD MAY  
13 ISSUE A LICENSE BY ENDORSEMENT TO ENGAGE IN THE PRACTICE OF  
14 VETERINARY MEDICINE IN THIS STATE TO AN APPLICANT WHO HAS A  
15 LICENSE IN GOOD STANDING AS A VETERINARIAN IN ANOTHER  
16 JURISDICTION IF THE APPLICANT PRESENTS PROOF SATISFACTORY TO THE  
17 BOARD THAT, AT THE TIME OF APPLICATION FOR A COLORADO LICENSE BY  
18 ENDORSEMENT, THE APPLICANT POSSESSES CREDENTIALS AND  
19 QUALIFICATIONS THAT ARE SUBSTANTIALLY EQUIVALENT TO THE  
20 COLORADO REQUIREMENTS FOR LICENSURE SET FORTH IN SECTION  
21 12-64-107. THE BOARD MAY SPECIFY, BY RULE, WHAT CONSTITUTES  
22 SUBSTANTIALLY EQUIVALENT CREDENTIALS AND QUALIFICATIONS."
