A BILL FOR AN ACT

101 **CONCERNING A PROHIBITION ON INGESTIBLE MEDICAL**
102 **MARIJUANA-INFUSED PRODUCTS.**

Bill Summary

Current law permits a medical marijuana-infused products licensee to produce edible products. The bill would prohibit medical marijuana-infused consumable food and beverage product manufacturing and sale.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 12-43.3-202 (2) (a), Colorado Revised Statutes, is
3 amended BY THE ADDITION OF A NEW SUBPARAGRAPH to read:

4 **12-43.3-202. Powers and duties of state licensing authority -**
5 **repeal.** (2) (a) Rules promulgated pursuant to paragraph (b) of
6 subsection (1) of this section may include, but need not be limited to, the
7 following subjects:

8 (XIV.5) PROHIBITING THE SALE OF MEDICAL MARIJUANA-INFUSED
9 PRODUCTS UNLESS THE PRODUCT IS PACKAGED:

10 (A) IN SPECIAL PACKAGING THAT IS DESIGNED OR CONSTRUCTED
11 TO BE SIGNIFICANTLY DIFFICULT FOR CHILDREN UNDER FIVE YEARS OF AGE
12 TO OPEN AND NOT DIFFICULT FOR NORMAL ADULTS TO USE PROPERLY AND
13 THAT DOES NOT ALLOW THE PRODUCT TO BE SEEN WITHOUT OPENING THE
14 PACKAGING MATERIAL; OR

15 (B) IN PACKAGING THAT IS LABELED "MEDICINAL PRODUCT - KEEP
16 OUT OF REACH OF CHILDREN"; _____

17 **SECTION 2. Safety clause.** The general assembly hereby finds,
18 determines, and declares that this act is necessary for the immediate
19 preservation of the public peace, health, and safety.
