2 **SECTION 1.** 39-22-3501, Colorado Revised Statutes, is amended

4 **39-22-3501. Voluntary contribution designation - procedure.**

7 Colorado state individual income tax return form shall contain a line
8 whereby each individual taxpayer may designate the amount of the
9 contribution, if any, the individual wishes to make to the adult stem cells
10 cure fund created in section 25-40-103, C.R.S.

11 ~~(2) This part 35 shall take effect on September 1 of the year that~~
12 ~~the executive director of the department of revenue files a written~~
13 ~~certification with the revisor of statutes that there are no more than~~
14 ~~fourteen other lines on the Colorado state individual income tax forms for~~

17 **SECTION 2.** 39-22-3503, Colorado Revised Statutes, is amended
18 to read:

19 **39-22-3503. Repeal of part.** This part 35 is repealed, effective
20 ~~January 1, 2012~~ JANUARY 1, 2017, unless the voluntary contribution to the
21 adult stem cells cure fund as specified in section 39-22-3501 is continued
22 or reestablished by the general assembly, acting by bill, prior to said date.

23 **SECTION 3. Act subject to petition - effective date.** This act
24 shall take effect at 12:01 a.m. on the day following the expiration of the
25 ninety-day period after final adjournment of the general assembly (August

1 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a
2 referendum petition is filed pursuant to section 1 (3) of article V of the
3 state constitution against this act or an item, section, or part of this act
4 within such period, then the act, item, section, or part shall not take effect
5 unless approved by the people at the general election to be held in
6 November 2012 and shall take effect on the date of the official
7 declaration of the vote thereon by the governor.
