Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB11-1080 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the House State, Veterans, & Military Affairs Committee Report  
2 dated February 24, 2011, page 16, strike lines 27 through 41 and  
3 substitute:

4           "(4) (a) There is hereby created in the state treasury the address  
5 confidentiality program surcharge fund, which shall consist of moneys  
6 received by the state treasurer pursuant to this section AND any moneys  
7 received pursuant to ~~section 24-21-204 (3), any gifts, grants, or donations~~  
8 ~~received by the department of state for the fund pursuant to paragraph (b)~~  
9 ~~of this subsection (4), and any moneys transferred to the fund from the~~  
10 ~~department of state cash fund created in section 24-21-104 (3) (b)~~  
11 SECTION 24-30-2104 (2). The moneys in the fund shall be subject to  
12 annual appropriation by the general assembly to the department for the  
13 purpose of paying for the costs incurred by the ~~secretary of state~~  
14 EXECUTIVE DIRECTOR OR HIS OR HER DESIGNEE in the administration of the  
15 ~~address confidentiality~~ program. All interest derived from the deposit and  
16 investment of moneys in the fund shall be credited to the fund. Any  
17 moneys not appropriated by the general assembly shall remain in the fund  
18 and shall not be transferred or revert to the general fund ~~of the state~~ at the  
19 end of any fiscal year. ~~except that the state treasurer shall transfer~~  
20 ~~unappropriated moneys to the department of state cash fund until such~~  
21 ~~time that all of the transfers made from the department of state cash fund~~  
22 ~~pursuant to paragraph (c) of this subsection (4) and section 24-21-104 (3)~~  
23 ~~(d) (XIII) have been repaid.~~

24           (b) ~~The department of state is authorized to seek and accept gifts,~~

1 ~~grants, and donations from private or public sources for the~~  
2 ~~implementation of the address confidentiality program. All private and~~  
3 ~~public funds received through gifts, grants, and donations shall be~~  
4 ~~transmitted to the state treasurer, who shall credit the same to the address~~  
5 ~~confidentiality program surcharge fund."~~

6 Page 17 of the report, strike lines 1 through 11.

7 Page 17 of the report, after line 30, insert:

8 "SECTION 3. Part 21 of article 30 of title 24, Colorado Revised  
9 Statutes, is amended BY THE ADDITION OF A NEW SECTION to  
10 read:

11 **24-30-2115. Address confidentiality program grant fund -**  
12 **creation.** (1) THERE IS HEREBY CREATED IN THE STATE TREASURY THE  
13 ADDRESS CONFIDENTIALITY PROGRAM GRANT FUND, REFERRED TO IN THIS  
14 SECTION AS THE "FUND", WHICH SHALL CONSIST OF ANY GIFTS, GRANTS, OR  
15 DONATIONS RECEIVED BY THE DEPARTMENT FOR THE FUND PURSUANT TO  
16 SUBSECTION (2) OF THIS SECTION. THE MONEYS IN THE FUND SHALL BE  
17 CONTINUOUSLY APPROPRIATED BY THE GENERAL ASSEMBLY TO THE  
18 DEPARTMENT FOR THE PURPOSE OF PAYING FOR THE COSTS INCURRED BY  
19 THE EXECUTIVE DIRECTOR OR HIS OR HER DESIGNEE IN THE  
20 ADMINISTRATION OF THE PROGRAM. ALL INTEREST DERIVED FROM THE  
21 DEPOSIT AND INVESTMENT OF MONEYS IN THE FUND SHALL BE CREDITED  
22 TO THE FUND. ANY MONEYS NOT APPROPRIATED BY THE GENERAL  
23 ASSEMBLY SHALL REMAIN IN THE FUND AND SHALL NOT BE TRANSFERRED  
24 OR REVERT TO THE GENERAL FUND AT THE END OF ANY FISCAL YEAR.

25 (2) THE DEPARTMENT IS AUTHORIZED TO SEEK, ACCEPT, AND  
26 EXPEND GIFTS, GRANTS, AND DONATIONS FROM PRIVATE OR PUBLIC  
27 SOURCES FOR THE IMPLEMENTATION OF THE PROGRAM. ALL PRIVATE AND  
28 PUBLIC FUNDS RECEIVED THROUGH GIFTS, GRANTS, AND DONATIONS SHALL  
29 BE TRANSMITTED TO THE STATE TREASURER, WHO SHALL CREDIT THE  
30 SAME TO THE FUND."

31 Renumber succeeding sections accordingly.

32 Page 18 of the report, after line 28 insert:

33 "SECTION 7. **Appropriation - adjustments in 2011 long bill.**  
34 (1) In addition to any other appropriation, there is hereby appropriated,  
35 out of any moneys not otherwise appropriated in the address

1 confidentiality program surcharge cash fund created in section 24-30-  
2 2114 (4) (a), Colorado Revised Statutes, for the fiscal year beginning July  
3 1, 2011, the sum of one hundred twenty-eight thousand eight hundred  
4 twenty-three dollars (\$128,823) and 2.0 FTE, or so much thereof as may  
5 be necessary, for the implementation of this act.

6 (2) For the implementation of this act, the cash funds appropriation  
7 made in the annual general appropriation act for the fiscal year beginning  
8 July 1, 2011, to the department of state, administration division, for the  
9 address confidentiality program, is decreased by one hundred sixty-four  
10 thousand nine hundred sixty-one dollars (\$164,961) and 2.0 FTE."

11 Renumber succeeding section accordingly.

12 Amend printed bill, page 1, line 101, strike "**PROGRAM.**" and substitute  
13 "**PROGRAM, AND MAKING AN APPROPRIATION THEREFOR.**".
